## MOTION FOR EXTENDED LENGTH OF APPELLATE BRIEF

Comes now Defendant/Appellant, Diego Rodriguez, a pro se appellant, to move this Court pursuant to Idaho Appellate Rule 34(b) to ask the court for permission to file an Appellate Brief in excess of the 50 page maximum stipulated in this rule. As I am still working on the Appellate Brief at this time, it has become quite evident that it will be remarkably difficult, if not impossible, to include everything that is necessary in this Appellate Brief within 50 pages.
