ADMINISTRATIVE ORDER

NO. 21-05-21-1

(REPLACING ORDER NO. 21-05-20)

The use or possession of video, audio, and photographic equipment¹ to cover, broadcast, or record court proceedings is permitted inside Ada County Courthouse courtrooms or other rooms where court proceedings are being held <u>only</u> with the prior written approval of the presiding judge in the particular proceeding sought to be recorded.

This approval can be requested by filing a written request, in the form reflected in Attachment A to this order. Prior to requesting such permission, the requesting person must read and agree to follow Idaho Court Administrative Rule 45: https://isc.idaho.gov/icar45.

The use or possession of video, audio, and photographic equipment to cover, photograph, broadcast, or record the clerk front counter area on the first floor; in courtrooms not in session; in hallways, stairwells or elevators or any other common area, or in any non-public area controlled by or affiliated with the court; and in any location on the second, fourth or fifth floors other than inside a courtroom that is in session,² is

¹This includes any camera, body cam, gopro, or any other type of device or equipment that can be used to photograph or record and these devises will not be allowed into a courthouse or court facility without permission outlined in this Order, but this Order does not prohibit entering with a cell phone, so long as the cell phone is not being used to photograph, video, broadcast or record.

² Recording, filming or broadcasting in a courtroom while in session is subject to the restrictions contained in the first paragraph of this Order.

prohibited without prior written approval of the Administrative District Judge or his/her designee. All requests for permission to film, broadcast or record in such locations must be submitted in advance to the Trial Court Administrator, using the form reflected in Attachment B, or other form as may be obtained from the Trial Court Administrator.

Written permission to record on the first floor lobby must be first obtained from the Ada County Sheriff lead courthouse security officer or the Administrative District Judge or their designee who will determine whether such proposed recording or photography would be disruptive to court proceedings or the business of the agencies in the courthouse; would presents concerns with the security and safety of the courthouse or persons therein; or otherwise should not be permitted for good reason. All requests for permission to film, broadcast or record in the first-floor lobby must be submitted in advance to the Trial Court Administrator, in the form reflected in Attachment B, or other form as may be obtained from the Trial Court Administrator.

Persons seeking to operate video, audio, or photographic equipment in an office or other space in the courthouse that is not controlled by or affiliated with the court or being used for court proceedings, other than the first floor lobby area of the courthouse, must obtain written permission from the elected official(s) or agencies controlling that space, prior to being allowed to bring the recording equipment into the building and prior to operating broadcast, video, audio, or photographic equipment in that space.

No one operating video, audio, or photographic equipment anywhere within or on the grounds of the Ada County Courthouse or on Court annexes or remote sites, is permitted to record courthouse employees, court staff or personnel, juveniles involved in court proceedings, or victims in a criminal case, without the express consent of those individuals. photographer/videographer knows or should know to be a juror) may be photographed, recorded or videoed anywhere within or on the grounds of the Ada County Courthouse or its annexes or remote sites or on any courthouse property without the express written consent of the juror and the presiding judge in the case on which the juror is serving.

Exempt from the prohibitions in this Order are cameras and equipment utilized by the Ada County Sherriff for security purposes and on-duty security officer assigned to court security. Further, any other law enforcement officer attending court in their official capacity, may bring in to the courthouse, or court annex or remote court site, their issued body worn camera and may record if responding to an incident in or at the courthouse or court annex or remote court site.

Any person violating the terms of this order may be removed and any recordings or images violating the order may be seized and/or deleted and/or the person may be charged with contempt pursuant to Idaho Code § 18-1801, and/or trespass pursuant to Idaho Code § 18-7008, and/or such other charge(s) as may be appropriate, and may be imprisoned and/or fined. See also Title 7, Chapter 6, Idaho Code; I.R.C.P. 75; I.C.R. 42.

This Order replaces Administrative Order No.21-05-20, and Administrative Order No. 18-12-07-01 is hereby superseded.
