Notice and Order on Receipt of Written Ex Parte or Prohibited Communications

On November 22, 2022, two e-mails were sent to the judge's e-mail address by Defendant Diego Rodriguez. The judge does not access her e-mail, read e-mails, or respond to e-mails while in the courtroom. The judge only uses i-Court in the courtroom so the judge can only see the digital record of a court file and matters actually filed in a court file during any hearing or trial. A copy of both e-mails sent on November 22, 2022 are attached to this notice and provided to all parties.

On November 29, 2022, the judge received a written ex parte or prohibited written communication bearing upon the substance of this case from the Defendant Diego Rodriguez. The communication is ex parte because a copy was not provided to all parties¹ and is now attached to this Notice and provided to all parties.² The Judge has not acted upon the substance of the communications.

The Court takes the following action:

The Court directs Diego Rodriguez to stop including Judge Lynn Norton's e-mail address on correspondence with the in-court clerk or the Clerk's Office. Since ex parte contact with the judge is prohibited, it is not permissible to include the judge on any e-mail to the in-court clerk or the Clerk's Office.

While the ex parte rules permit the Clerk's Office to have contact with a party for scheduling, administrative matters, or emergency matters which do not address substantive matters or issues on the merits, the judge should not be included or copied on those e-mails.
