MEMORANDUM IN SUPPORT OF MOTION FOR CLARIFICATION OF ORDER

Plaintiffs, by and through their attorneys of record, Holland & Hart LLP, hereby submit this Memorandum in Support of their Motion for Clarification of Order entered December 13, 2022.

I. ARGUMENT

Idaho Rule of Civil Procedure 60 permits the court to:

correct a clerical mistake or a mistake arising from oversight or omission whenever one is found in a judgment, order, or other part of the record. The court may do so on motion or on its own, with or without notice.

I.R.C.P. 60(a).

Idaho Rule of Civil Procedure 11.2(b) provides that a party may move for reconsideration of "any order of the trial court entered before final judgment[.]" On December 13, 2022, this Court sua sponte issued an order vacating and resetting the hearing for Plaintiffs' motions to amend to allege punitive damages, which had been set for hearing on December 20, 2022. The Court's order stated that Plaintiffs' filing was untimely because "the unredacted memoranda and many of the unredacted declarations . . . were not filed until December 7, 2022 (which is less than fourteen days before the hearing)."

Plaintiffs' entire filing of the motions for punitive damages was timely filed. Plaintiffs filed electronically on December 5, 2022—one day early.

Plaintiffs then filed the motion to seal with supporting documents (including the unredacted memoranda and declarations and exhibits) in person at the Ada County courthouse on December 6, 2022. Due to the volume of data submitted, Plaintiffs duly hand-delivered these unredacted documents via external drive.

On December 7, 2022, Plaintiffs' counsel's office received a call from the clerk's office

stating that the pdf files on the thumb drives should be printed out and provided to the clerk's

office again. Plaintiffs did so, understanding that this was a convenience for the court, as the files

had already been submitted earlier.

All filings have been date-stamped by the Court for December 6, 2022, which is fourteen

days prior to the December 20, 2022 hearing date.

Plaintiffs respectfully request that this Court reconsider its December 13, 2022 order

vacating and resetting the hearing on the motions to amend to allege punitive damages.

II. **CONCLUSION**

For the foregoing reasons, Plaintiffs respectfully request the Court clarify its December

13, 2022 order.
