- I, C.P. "Abbey" Abbondandolo, declare and state as follows:
- 1. I make this declaration based on my personal knowledge.

DECLARATION OF C.P. "ABBEY" ABBONDANDOLO IN SUPPORT OF MOTIONS FOR LEAVE TO AMEND COMPLAINT TO ALLEGE PUNITIVE DAMAGES - 1

- 2. I am the Senior Director of Security for St. Luke's Health System, Ltd., in Boise, Idaho ("St. Luke's"). I am not an agent or employee of the Idaho Department of Health and Welfare ("DHW") or any other governmental entity.
- 3. I spent 32 years with Houston Police Department, with 21 of those years as a homicide detective. I also spent 31 years with St. Luke's Houston, where I was the head of security. I have been with St. Luke's Boise for the past 9 years.
- 4. On March 12, 2022, I learned that a group of protesters had gathered at the St. Luke's Meridian Medical Center and were blocking the emergency vehicle entrance bay. A true and correct copy of the incident report related to the March 12, 2022 emergency bay protest blockade is attached as **Exhibit A**.
- 5. I soon learned from my security team and social media postings that the protest at St. Luke's Meridian was organized by Bundy and Diego Rodriguez and related to an ongoing Child Protective Services (CPS) case. The infant involved in the CPS case was taken to the St. Luke's Meridian Medical Center emergency department by law enforcement on March 12, 2022.
- 6. The infant was transferred to St. Luke's Children's Hospital at St. Luke's Regional Medical Center in Boise. After the infant's transfer, I observed protesters outside of the main hospital building at St. Luke's campus in Boise, Idaho from March 13, 2022 through March 18, 2022. These protests were also organized by Bundy, Rodriguez, and their entities. The height of the protests was on March 15, 2022, when there were several hundred protesters outside the main building.
- 7. I actively monitored the protesters during the dates they were present at St. Luke's in Boise. I monitored their activities in numerous ways, including by going outside approximately ten (10) different times during the relevant time period, by watching real time live DECLARATION OF C.P. stream videos being posted by protestors on social media platforms, by directly monitoring protestor's activities through the windows of the building, and by monitoring St. Luke's security camera feeds. St. Luke's has 950 cameras across its system, so I was able to readily observe all areas outside the building where the protesters had gathered.

- 8. While observing protesters, I saw many of them were open-carrying handguns. One protester had a long knife strapped to his belt. Photographs of some of the protesters were gathered by St. Luke's security team under my direction during the March protests. True and correct copies of those photographs are attached as **Exhibit B**.
- 9. In addition to personally monitoring the protestor's activities, I received reports on their activities from staff and members of St. Luke's security team. I also received reports from security partners including members of the Boise Police Department and State Police who were present at the St. Luke's downtown campus during the protests to provide additional security support for the hospital. Prior to the protests, the Federal Bureau of Investigation (FBI) advised that threats against St. Luke's had been noted on social media.
- 10. On March 15, 2022, St. Luke's leadership made the decision to lockdown the main building on St. Luke's downtown campus for a period of about two (2) hours due to the real and present danger to the safety of patients and staff presented by the presence of the hundreds of armed protestors outside.
- 11. Based on the information I was receiving from staff and St. Luke's security partners, and from my personal observations, there were moments during the period of lockdown that I was not confident the locked doors would be sufficient to keep the building and the people in it secure from the protesters. My concern was heightened by my observation of live stream videos of protesters and other organizers connected to Bundy, Rodriguez, and their entities who DECLARATION OF C.P. were actively seeking information about the entrances into the building, including seeking maps of tunnels which serve utility purposes for the downtown St. Luke's campus.

- 12. A protest phone call campaign was organized that completely jammed St. Luke's phone systems on several occasions for more than an hour at a time. The phone number for St. Luke's switchboard, which fields all incoming public calls to the hospital, was published on social media by Bundy, Rodriguez, and their entities. Phone calls were received by St. Luke's from approximately 30 different states. Some of the callers left threatening messages, while others relayed threatening or disruptive messages to the St. Luke's switchboard operators. Heat maps were produced by St. Luke's security team to show the concentration of calls received from the various states from March 13 through March 16, 2022. True and correct copies of the heat maps are attached Exhibit C. St. Luke's retained records of threatening or disruptive messages for security purposes. True and correct copies of the noted messages left by supporters Bundy, Rodriguez, and/or their entities are included as Exhibit D. One of the callers indicated that St. Luke's should be on the watch out for a trucker blockade of the streets surrounding St. Luke's. A true and correct copy of the recording of that call is attached as Exhibit E.
- 13. Due to the ongoing threat of a physical breach of the building by protesters during the height of the protests on March 15, I worked with the St. Luke's medical staff and others to formulate a plan to keep the infant safe from harm should a breach of the building occur. We made the plan not only to protect the infant, but also to protect the staff in the event of a confrontation with protesters inside the building. We made the plan because, in my estimation as an experienced law enforcement and security professional, there was a real and present risk the protesters could enter the building—despite the lockdown.

- 14. In addition to managing the threat posed by the protesters outside, I also had to manage threats from the inside of St. Luke's. For as many good apples as we have, we have bad apples as well. I knew that there were people inside St. Luke's, likely staff who were aligned with the protestors and who were communicating information about St. Luke's actions to secure the building to the protestors outside.
- 15. The diversion of attention and resources to manage the risks posed by the March protests meant that regular and important work was delayed, including the regular checks performed by security staff on high risk patient groups, assisted transfer of patients in custody to different areas of the facility for testing or for other medical or administrative reasons, and assisting employees with basic security-based requests, such as lockouts due to badge malfunctions and other issues.
- 16. After the protesters finally stopped physically showing up at the hospital on or around March 18, 2022, the threat to St. Luke's and its providers did not end. Several of St. Luke's providers were doxed by Bundy, Rodriguez, and their affiliated entities. My team at St. Luke's has worked with the doxed providers and other concerned providers to promote their safety and well-being both at work and at home. In addition, my team continues to monitor online chatter and media concerning St. Luke's and its providers.
- 17. St. Luke's has also undertaken research and investment in new security infrastructure as a result of the threats created by the March 15 protests. These efforts represent a significant capital expense. The efforts are necessary because the false information about St. Luke's and its providers posted online by Bundy, Rodriguez, and their entities remains on the Internet. Because of this, the "cause against medical kidnapping" could be taken up at any time in the future by someone else who comes across the false information.

18. In my role as Senior Director of Security, I oversee a team of dedicated security

leaders. As part of my role, I also manage the work of St. Luke's Threat Assessment Team and

coordinate with St. Luke's Emergency Management Team. Through coordination and

contributions from St. Luke's security leaders and members of those teams, we documented the

events from March 12 through March 18, 2022 in real time. The results of the documentation

were combined by my team into a report dated April 8, 2022, entitled "Child Protective Services

Protests, March 12 to March 18, 2022." A true and accurate copy of the report is attached as

Exhibit F.

Phone Call Heat Map



Synopsis

During the early hours of March 12, 2022, The St Luke's Health System experienced protests organized by Diego Rodriguez and Ammon Bundy regarding an ongoing child protection case. The involved child was brought to the Meridian Medical Center emergency department by law enforcement at about 0100 hours. A "pop-up" protest that blocked the ambulance bay entrance resulted in the arrest of independent gubernatorial candidate Ammon Bundy and two others. About an hour later, the involved child was transferred to the St Luke's Children's Hospital at the St Luke's Regional Medical Center.

Protests averaging 100-150 people continued through 3/15/2022 culminating in the Boise facility being locked down and being placed on divert for about two hours on the final day of the large protests. Additionally, the CPS case was publicized by the protestors on social media organizing a phone call and email campaign. Phone calls were received from 30 different states. Threatening and aggressive social media posts were made across the country regarding the case, involving law enforcement, medical providers and Idaho Department of Health and Welfare staff members. Several of these individuals, including a SLHS provider were posted on the primary website Freedomman.org/Cyrus as the "kidnappers" resulting in protests and "door hanger" campaigns at the homes and neighborhoods of some of the involved people. The focus of the protests shifted from the Boise hospital to the Department of Health & Welfare following the discharge of the child to CPS custody.

Although no single organization claimed responsibility for the protests and other activities, members of the People's Rights Network, Health Freedom Idaho and #medicalkidnap community were featured prominently. These included Ammon Bundy, Miste Karlfeldt, Sarah Anne Clarendon, and several Idaho politicians. The incident was publicized largely on "Patriot" podcasts and video outlets such as "Pete Santilli Show", "Stew Peters Network", "Critical Exposure Network", and "Patriot Street Fighter". The protests were also presented on mainstream local and national news sources.

Daily Summary - Saturday 3/12/2022

Following an "Attempt To Locate" by law enforcement, the parents and child were stopped by the Garden City Police Department on Chinden Boulevard at about 2338 hours, 3/11/22. Livestreams of the stop and arrest were broadcast by the child's mother during the arrest. The Meridian Police Department brought the child to the Meridian Medical Center emergency department at about 0100 hours on 3/12/2022. Dr Rachel Thomas evaluated the child and arranged transfer to the Children's Hospital at the St Luke's Regional Medical Center in Boise where the child was admitted by Dr Natasha Erickson. At 0130, Security Officers Woods and Buzzini were dispatched to the emergency department for a disturbance (See Security Incident Report IM22-081). A growing group of protestors, seemingly being directed by Ammon Bundy, were beginning to block the ambulance bay and access to the department. Although the group was offered to protest at the Northeast of St Luke's Street, they refused resulting in a request for assistance from the Meridian Police Department. The MPD arrested Ammon Bundy and two others at about 0130 hours.

The child was surreptitiously transferred to the Boise facility at about 0200 hours. Due to the Meridian hospital's experience, leadership at the Regional Medical Center stood up at the Hospital Incident Command System to respond to the situation. After bailing out of the Ada County Detention Center, Bundy published "Idaho CPS Took Baby Cyrus" video on YouTube. During the video, Bundy states, "I've just never experienced more wickedness in my life..." and "...we'll start to put a lot of pressure on these

people. We're going to need your help to make phone calls to the hospitals to wherever..." The switchboard phone number was published on social media.

The protestors overwhelmed the SLHS phone system for about an hour between 1000-1100 hours on Saturday morning, 3/12/2022. Additionally, the incident and calls for action were publicized on social media using the #savebabycyrus tag.

Protests were organized for 1300 hours at both the Boise and Meridian hospitals. Prior to the protests, the Federal Bureau of Investigation advised that threats against the Boise hospital had been noted on social media resulting in the facility being placed into partial lockdown. An estimated 150 people protested in Boise causing additional security officers to be called in and the Boise Police Department being requested for assistance. The Meridian hospital also activated their HICS, called in additional security and placed the MPD on standby however no protests manifested at the hospital.

The 3/12/22 protest was livestreamed by Miste Karlfeldt. In the video, a demonstrator is observed handing out "Wanted Posters" of the involved Nurse Practitioner Aaron Dykstra from Functional Medicine of Idaho, MPD Detectives and the CPS Social Worker. Robert Jones, who protested "medical kidnapping" at the Boise hospital in 2019, was photographed in the crowd wearing a sidearm. A man identified as Owen Kirkham, a protestor often seen during previous Anti-Vaxx protests, was also photographed wearing a large knife during the protests on 3/12/22 and 3/14/22. Additionally, Threat case #342 were interviewed during the protest by Karlfeldt.

The parents of the child spent a large portion of the day waiting in the Boise emergency department lobby. Although reportedly updated on the child's condition, they were not allowed to visit with the child due to the CPS process. The mother provided breast milk to be delivered to the child.

Daily Summary - Sunday 3/13/2022

Protests between 1000 hours to 2000 hours were announced through social media. As a result, the Boise hospital once again went into partial lockdown and added additional security officers. The telephone systems continued to be overwhelmed by phone calls from protestors. Overnight, the SL Connect received a voice message that 100 members of the People's Convoy who were in Washington DC at the time, were enroute to Boise to blockade the hospital. Although the group never appeared at the hospital, it is representative of several calls from out of state over the course of the protests advising that the truckers or members of Patriot militia groups were enroute. Another social media threat by David Vail stated "This is disgusting and wicked. This is a grounds (sic) for arms and war. No more peaceful protest in situations like this." It was later determined through the Threat Assessment Team investigation and assistance from the Idaho Criminal Intelligence Center that the threatener and his group were out of state. Similar posts, the distributed wanted posters and door hangers created personal safety concerns for involved caregivers. The Threat Assessment Team created personal safety plans for those staff members. The fear of "doxing" lead to the Threat Assessment Team requesting that the local FBI field office, ICIC and SLHS Cyber-Security monitor for posts relating to the child's care team.

The SLHS is maintaining COVID restrictions and limiting visitors to hospitals. During the protests, several protestors attempted to enter the facility wanting to use restrooms. Other individuals, claiming to represent the child's parents also tried to enter the facility, including S. Deviney who claimed to be an attorney for the family. State legislators Zito and Scott also demanded entry to review the child's medical records.


The SLHS administration, CARES Team and H&W met in the morning to arrange a parental visit between 1930 and 2130. Although the parents complied with safety expectations for the visit, photos and accusations about the child's care were published on Freedomman.org/cyrus by the parents and the child's grandfather Diego Rodriguez. It was also learned that SLHS employees were attempting to obtain information about the child to be leaked to the family. The father of another pediatric patient was also suspected of taking photos of staff and the pediatric unit. This caused the SLHS to tightly manage communications to employees and practice strict operational security.

Daily Summary - Monday March 14, 2022

The protests at the Boise hospital began to become noticeably more aggressive including complaints to security that incoming staff and patients were being harassed by the protestors. One patient complained that a protestor had used a bullhorn to shout in his ear as he entered the building. Other patients voiced concerns that they could not access medical care due to the protests. The hospital was placed into a partial lockdown once again. The Little Luke's facility requested a security presence due to the protests and concerns about the children's safety. The social media campaign also intensified and included the work phone number for Dr Erickson. The context of the social media, emails and phone calls also began to move from #medicalkidnap to Q-Anon theories.

The child's parents were again allowed to visit with the child from 1430 to 1630 hours. The father also made the formal request for the child's medical records. Partial medical records with the care team names redacted for security reasons was provided at about 1800 hours. He would receive the remaining records such as medical images the following day.

Further political influence was exerted at about 1845 hours when the Lt Governor J. McGeachin and six legislators met with administration and demanded access to the child's health records. McGeachin would later post a video on social media about the meeting.

Daily Summary - Tuesday March 15, 2022

The Threat Assessment Team received information from the FBI and ICIC that credible human intelligence indicated that some protestors were intending to storm the hospital and forcibly remove the child. Bundy appeared to be aware of this threat when he published the "Call to Action-Baby Cyrus, now or never" video on YouTube that morning. At 1 minute 39 seconds into the video, Bundy tells viewers "Now I have to say that I'm not okay with any of this to be honest with you, if justice was to be served we would go into the hospital take that baby and we'd give it back to their mother and then if we were further to administrate justice we would find those that were accountable and we would prosecute them and you know make them pay for the damages that they cause to this family and assure that this never happens again that's what should happen and I will say this that I'm not alone in those feelings but we also have had to suppress those thoughts and actions because we are trying to give the people that are making the decisions that are doing this thing to them give them a chance to correct this issue so we don't have to do it for them." Later in the video at 4 minutes 46 seconds, "I will say again to all of you that are out there, I know that there are groups, Patriot groups, that have wanted to come and just do what needs to be done and I have been kind of holding the floodgates from that happening trying to, you know, make sure you guys don't do that yet because I believe that we have a chance here today to get this straightened out and if not then you know I can't hold you back for what you're going to do..."

Earlier, the child had been cleared for discharge by the CARE Team and an after-care plan was created. Due to the ongoing CPS case, the child was to be kept in their custody as the scheduled custody hearing set for 1300 hours had been continued. Following his court appearance, Bundy published another video on YouTube titled "Emergency Message Cyrus" at about 1300 hours. The video called his supporters to the Boise hospital and "make some noise." At about 40 seconds into the video, Bundy tells viewers "I don't know (how) we're gonna have to straighten this out, but we need to go back there and get this straightened out so anybody who's at the courtroom please go to the hospital." He concludes the video "Yeah! Are you ready?"

A large group of protestors arrived at the hospital shortly after 1300 hours. Unlike the previous protests, the group strayed from their usual location of Bannock Street and Avenue B and began to encircle the hospital at all four corners. There were also reports of a group of protestors on the East side of the Children's Pavilion. Additionally, of protestor vehicles drove around the hospital, honking their car horns. Several protestors encroached onto SLHS property by standing on the U driveway near the emergency department entrance. At least two were believed to be related to Bundy including a brother and patriarch Cliven Bundy. The Boise hospital went on full lock down and additional resources were provided by the Boise Police Department to secure the building. The approximately two-hour lockdown

disrupted care and operations including the emergency room being placed on divert status. Due to the previous intelligence and crowd behavior, the pediatric unit was assigned a security presence inside the main doors and barricaded skybridge access to the Children's Pavilion. At about 1357 hours, the child was discharged from the hospital to CPS custody with the assistance of local and state law enforcement. A social media post at about 1530 hours, indicated that the protestors had been seeking information regarding access to the hospital's tunnel system.

Despite social media chatter indicating that some of the protestors were aware of the discharge, the protest continued. A security officer reported that an employee pulling a wheeled bag was accosted by protestors demanding to inspect the bag to ensure that the child was not being covertly removed. At 1830 hours, 80 protestors were reported by security as still being at the hospital.





Figure 11: Wanted Poster on Peoplerights.org 3/15/22

Daily Summary - Wednesday March 16, 2022

The 15th appeared to be a watershed for protests at the hospital. Several comments on the group's social media reflected dissension about impacting the healthcare of other patients. Following the custody hearing deciding that the child should remain with CPS, the protests began to focus on the Department of Health And Welfare. Harassing phone calls continued to be received including Dr Erickson's work phone number. Overnight, the doctor's photo was published as a "kidnapper" on the Freedomman.org/cyrus site. In an early morning YouTube video, Bundy referred to the situation as "it truly is a, you know, good being called evil and evil being called good." While referring to the involved Judge Fortier and the alleged number of CPS cases she has presided over, Bundy states "...you know, looking into her and she's taking hundreds of children and she's done it with this Dr Natasha D Erickson here in Idaho and these doctors work in conjunction with CPS and with these judges."

The hospital tunnel system was checked by the SLHS K9 unit and the Threat Assessment Team evaluated the vulnerabilities posed by the system. As a result of the 3/15/22 protest, the facility's CUP building was placed on "weekend status" which involves among other precautions, securing the exterior access points and better controlling access. The K9 unit also made rounds of the pediatric unit and the hospital as emotional support animals to calm staff and patients.








Figure 13: Dr Erickson on Freedomman.org/cyrus

Daily Summary - Thursday March 17,2022

Although the protests were focused on the Department of Health and Welfare building in downtown Boise, the protests impacted the Boise hospital. Due to the number protestors walking past the Little Luke's childcare facility, the building went into "shelter in place" for the duration of the protests. Social media, phone calls and protestors at the Boise hospital dramatically declined but persisted.

Daily Summary – Friday March 18, 2022

At 0645 hours, security provided an escort for the CARES Team providers to conduct follow up care for the child. Later in the day, the parents were allowed an "extended visitation" allowing the child to go home with them, but CPS retained custody.

Harassing phone calls, ongoing social media posts and emails continued to be received by the Boise hospital. On March 18, Bundy published another YouTube video "You will not take our children." Bundy remarked that "those culpable in this case must not live in comfort until he is home" as he announced a planned protest at the home of Judge Fortier. He then provided her home address. "I'm asking you to be there. Now Patriot groups all across Idaho, and the country I cannot try to hold you back any longer. What is happening in this case is so atrocious and ongoing that I cannot justify trying to hold you back any longer. Whatever you do, you do on your own, but it is not acceptable that Cyrus is not home with his loving family, and I cannot justify holding you back any longer." Bundy concludes the video by calling for whistleblowers regarding the child's location and other information. "So, CPS agents, police officers, neighbors, anybody else - if your heart is pricked by this event and you have any information about the location or well-being of little baby Cyrus, please submit these details by going to peoplesrights.org/cyrus." This video has since been removed by YouTube for violation of community standards and bullying.

Conclusion

Although protests at the health system have ended, Diego Rodriguez continues to publish blogs on Freedomman.org/cyrus relating to the case including the release of a CARES team provider's name. The child has been treated by the St Alphonsus Hospital in Boise. Rodriguez has released portions of law enforcement reports, video, and personal health information during and after the protests at St Luke's. An increased security posture is being maintained by the health system due to the continued commentary on Freedomman.org. The Threat Assessment Team continues to monitor the evolving situation.



Telephone Call Map






