Plaintiffs, St. Luke's Health System, Ltd., St. Luke's Regional Medical Center, Ltd.,

Chris Roth, Natasha D. Erickson, M.D., and Tracy W. Jungman, NP (collectively "Plaintiffs"),

by and through their attorneys of record, Holland & Hart LLP, hereby move this Court to sanction Ammon Bundy, Ammon Bundy for Governor, and People's Rights Network (collectively, the "Bundy Parties") pursuant to Idaho Rule of Civil Procedure 30(d)(3) and Idaho Rule of Civil Procedure 37(d) because the Bundy Parties failed to attend Plaintiffs' properly noticed depositions set on January 31, 2023 (Ammon Bundy), February 2, 2023 (People's Rights Network) and February 7, 2023 (Ammon Bundy for Governor).

Plaintiffs also seek an order pursuant to Idaho Rule of Civil Procedure 37(a) compelling the Bundy Defendants to respond to (1) Plaintiff St. Luke's Health System, LTD's Second Interrogatories, First Requests for Production to Defendant Ammon Bundy, served October 19, 2022; (2) Plaintiff St. Luke's Health System LTD's First Interrogatories and Requests for Production to Defendant Ammon Bundy for Governor, served October 24, 2022; and (3) Plaintiff St. Luke's Health System, LTD's First Interrogatories and Requests for Production to Defendant People's Rights Network, served December 9, 2022.

Plaintiffs also seek an award of their reasonable costs and attorney fees incurred in filing this Motion pursuant to Idaho Rule of Civil Procedure 30(d)(3), Idaho Rule of Civil Procedure 37(d)(3), and/or Idaho Rule of Civil Procedure 37(a)(5)(A).

This Motion is supported by the pleadings and documents on file herein, along with the Memorandum in Support of Motion for Sanctions and to Compel and the Declaration of Erik F. Stidham filed contemporaneously herewith.

Oral Argument is requested.
