Dear Honorable Judge Norton:

I've never written to a Judge before; however, I believe what is happening in your Court is important enough for such correspondence.

St. Luke's Hospital is suing Ammon Bundy and Diego Rodriguez, using the law office of Holland & Hart to weaponize the Court System. They're flooding the defendants with all kinds of legal demands and piling-on with huge monetary penalty threats.

Our Nation has a *Bill of Rights*. One such right is the FREEDOM OF SPEECH. From time to time you hear about organizations with *deep pockets* using their wealth to destroy their adversary and this seems to be one of those times.
