- I, Kelly Shoplock, being first duly sworn upon oath, depose and state as follows:
- 1. I make this declaration based on my personal knowledge.
- 2. I am a social worker for the Idaho Department of Health and Welfare, in the division of Family and Community Services, Child and Family Services.
- 3. I am aware of statements that Diego Rodriguez has made about me, publicly online through his freedomman.org web site. Among other things, Rodriguez falsely states that I am "a social worker in Idaho's child trafficking machine, called CPS (Child Protective Services), but better described as Child Profiting Systems." Rodriguez's doxing and false accusations are harassing and troubling.
- 4. I understand a Protective Order was entered by the Court in this lawsuit on January 19, 2023, and that the purpose of the order was to prevent intimidation and harassment of witnesses and potential witnesses, like myself.
- 5. Despite the entry of the Protective Order, Rodriguez continues the publication of defamatory statements that include my image where he calls me, among other things, an "evil cog in Idaho's Child Trafficking Machine", an "evil woman", and a "frustrated tyrant." The image is led by the following statement: "Kelly and Joseph Shoplock, please take into consideration what God said about people like you who are accomplices to kidnapping:"

- 7. My husband has faced questions in his workplace and otherwise about Rodriguez's false accusations about my husband's behavior. I worry about the safety of our children because of the false, harassing, and threatening accusations Rodriguez has posted on his web site about myself and my husband.
- 8. The doxing and false accusations by Rodriguez of and about me have impacted my ability to do my job by causing distrust by clients, parents, and/or guardians I work with. Specifically, the accusation that I am a "child trafficker" continues to come up for me professionally on a regular basis.
- 9. The false narrative promoted by Rodriguez and Ammon Bundy that CPS social workers and others who work for our office are involved in a "child trafficking machine" that puts profits over the welfare of children in Idaho has impacted the sense of safety and security I feel at work.
- 10. The doxing, misrepresentations, and rhetoric Rodriguez has used against me cause me ongoing stress and anxiety. I am concerned for the safety of my family, colleagues, clients, parents and guardians of clients, and myself.
- 11. Rodriguez's tactics of intimidation made it difficult for me to decide to provide this affidavit to the Court.
