Notice and Order on Receipt of Written Ex  
Parte or Prohibited Communications

On May 30, 2023, the Court received a written ex parte or prohibited written communication by e-mail from someone named TD Cummins.

The communication is ex parte because a copy was not provided to all parties.<sup>1</sup> The written communication is attached.<sup>2</sup>

The Court considers the ex parte request to be authorized as an administrative matter which does not address substantive matters or issues on the merits. The Court reasonably believes that no party will gain a procedural or tactical advantage as a result of the ex parte communication.<sup>3</sup>

The court takes the following action: Public Records Requests are not submitted directly to the judge. Public Records Requests must be submitted to the Clerk of the District Court, 200 W. Front Street, Boise, ID. Instructions for submitting a Public Records Request to the Ada County Clerk can be found at <https://adacounty.id.gov/clerk/public-records-request/>

As far as a request for the warrant, unreturned arrest warrants are sealed in the court file and are exempt from public disclosure pursuant to Idaho Court Administrative Rule 32(g).
