- 1. I am a research consultant working as an independent contractor. I make this declaration based on my personal knowledge.
- 2. I am a research consultant working as an independent contractor. I have a master's degree in psychology. Before becoming an independent contractor, I spent five years as a researcher at Persuasion Strategies, an integrated team of nationally recognized litigation consultants, legal graphics professionals, and video professionals. As a research consultant, I collaborate with trial consultants and attorneys across the country to provide litigation support.
- 3. I was contracted by Holland & Hart to collect Defendants' and their followers' media appearances, internet posts, and public communications.
- 4. To collect the data, I regularly monitored Defendant Diego Rodriguez's website, freedomman.org.
- 5. I reviewed People Against Child Trafficking, P.A.C.T. (Official) Telegram Group ("P.A.C.T. Telegram Group"), a Telegram group that is open to the public but requires a Telegram account to access. As of the date of this declaration, the P.A.C.T. Telegram Group is still accessible online to Telegram subscribers at the following website, <a href="https://t.me/peopleagainstchildtrafficking">https://t.me/peopleagainstchildtrafficking</a>.
- 6. **Trial Exhibit 339** is a true, accurate, and complete copy of a video I downloaded from the P.A.C.T. Telegram Group.
- 7. On May 10, 2023, Defendant Diego Rodriguez gave an online, publicly accessible live "presentation" that he titled, "Government Subsidized Child Trafficking." This presentation was given via Zoom at the following link,
