DECLARATION OF STEPHEN PIGGOTT - 1

- I am the Momentum Program Director at Western States Center. I make this declaration based on my personal knowledge.
- 2. I am a Program Director at Western States Center, a 501(c)(3) public charity designed to promote justice and equality and defend democracy. I have spent the past fifteen years investigating, monitoring, and exposing extremist organizations. One organization that I've monitored extensively, and that I continue to monitor, is the People's Rights Network.
- 3. I joined the People's Rights Network's in 2020 in order to investigate the organization and monitor its activities. When I joined People's Rights Network, I was prompted to enter my name, phone number, email address, and state of residence. I signed up using an alias and carefully constructed credentials. Holland & Hart did not ask me to join this group. I joined it in the course of my job duties for Western States Center.
- 4. I also joined the People Against Child Trafficking, P.A.C.T (Official), Telegram group Holland & Hart did not ask me to join this group. I joined it in the course of my job duties for Western States Center.
- 5. I also signed up to received emails from Diego Rodriguez's website, freedomman.org. Holland & Hart did not ask me to join this group. I joined it in the course of my job duties for Western States Center.
- 6. Because it takes months or years to develop a credible alias and fully infiltrate an extremist organization, I do not want my membership details in any of these groups to become public.
- 7. I sent Holland & Hart emails, Baby Cyrus Telegram Group screenshots, video alerts, and audio alerts that I received from my membership in the People's Rights Network, the People Against Child Trafficking, P.A.C.T (Official) Telegram group, and freedomman.org.

8. Trial Exhibits 178, 593, 595-597, 598-606, 607-608, 629, 644, and 717 are true,

accurate, and authentic copies of records I received from People's Rights Network, the Baby

Cyrus Telegram Group, and freedomman.org.

9. Trial Exhibits 178, 644 are true, accurate, and authentic alerts I received from

People's Rights Network.

10. Trial Exhibits 597, 605, 606 are true, accurate, and authentic screenshots of the

People Against Child Trafficking, P.A.C.T (Official) Telegram group.

11. Trial Exhibits 593, 595, 596, 598-604, 607, 608, 629, 717 are true, accurate, and

authentic copies of emails I received from freedomman.org. Holland & Hart has redacted my

email address to protect my identity and preserve so I can continue investigating and monitoring

the groups.
