- 1. I am a nurse practitioner at St. Luke's CARES (Children at Risk Evaluation Services). I make this declaration based on my personal knowledge.
- 2. I am a Plaintiff in this case, and I make this declaration in order to expedite the authentication process for documents that I intend to testify about during the damages hearing in this matter.
- 3. I personally reviewed the Infant's medical records when treating him. **Trial Exhibit 513** is a true and correct copy of excerpts of the Infant's medical records with St.

  Luke's, which were attached as an exhibit to my December 6, 2022, Declaration in Support of Motions for Leave to Amend Complaint to Allege Punitive Damages.
- 4. As a result of Defendants' conduct, I have taken safety measures to protect my family, my friends, and myself. On May 12, 2022, I purchased a home security system from Amazon. **Trial Exhibit 514** are true and correct copies of the receipts for the security system that I purchased. Personal information has been redacted safety and privacy reasons, including information regarding the order number, shipping address, payment method, and billing address.
- 5. I sent and received text messages pertaining to this case and my care and treatment of the Infant. I personally took my phone to a third-party vendor, Streamline Imaging, to have my text messages extracted and put into a report. **Trial Exhibit 515** is a true and correct copy of the text message report that I received from the third-party vendor.
