**NOTICE OF INTENT PURSUANT TO  
IDAHO RULE OF EVIDENCE 902(11)**

Plaintiffs, by and through their attorneys of record, Holland & Hart LLP, hereby provide notice of their intent to offer evidence pursuant to Idaho Rule of Evidence 902(11).

Idaho Rule of Evidence 902(11) permits the admission of certified domestic records of a regularly conducted activity. It provides, in relevant part, that the proponent of such records must give adverse parties “reasonable written notice of the intent to offer the record – and must make the record and certification available for inspection – so that the party has a fair opportunity to challenge them.” I.R.E. Rule 902(11).

Here, all adverse parties are in default. All records Plaintiffs intend to offer pursuant to Rule 902(11) are available for inspection. Plaintiffs’ trial exhibit list has already been filed. *See* June 6, 2023 Plaintiffs’ Trial Exhibit List. 


