DENYING REQUEST TO INSPECT,
DUPLICATE OR TRANSCRIBE
EXEMPT OR SEALED RECORDS

On July 24, 2023, the Court received a Request to Inspect, Duplicate or Transcribe Exempt or Sealed Records from Kyle Pfannenstiel, representing the Idaho Capital Sun. The request is for a copy of the warrants of arrest/attachment issued in this case against Ammon Bundy and Diego Rodriguez as well as audio recordings from court hearings where the warrants were ordered by the Court.

Unreturned arrest warrants are sealed in the court file and are exempt from public disclosure pursuant to Idaho Court Administrative Rule 32(g). Therefore, Defendant's request for a copy of the warrant of attachment is denied pursuant to Idaho Court Administrative Rule 32(g).

The requesting party also requests updates on the warrants. It is not the Court's job to inform third parties of the status of any outstanding warrants. Law enforcement agencies may disclose the information at their discretion. The Ada County Sheriff's Warrant webpage is available at: <https://apps.adacounty.id.gov/sheriff/reports/warrants.aspx>. This website may allow the requesting party to track the status of warrants.

As to the request for audio recordings of the court proceedings when the Court ordered certain warrants be issued, these may be purchased from the Trial Court Administrator's office, Transcript Department. You will need to specify the date(s) of the court hearings for which you desire to purchase the audio recording. The Court has no knowledge of any requested court proceedings that were sealed, so these audio recordings may be sought without a court order by making a request for audio recordings. Therefore, this request is denied without prejudice and the requester should file a new request for the specific dates for audio recordings with the Transcript Department.


