1 MR. JAMES WHITE: Oh, man. I know I got to get my thoughts out here, but I'm having  
2 a hard time here, but I got to get--I got to let you know what's going on to help this little family,  
3 and I've just never experienced more wickedness in my life. My good friend, Diego, and his  
4 family, the police pulled them over and they took baby Cyrus, his grandson. There's not a better  
5 family in this world. I mean, there is--it would be hard to find a more loving, tight, wonderful  
6 family than, than Diego and his family and I mean, they took their baby, their baby. They took  
7 Marissa, Diego's youngest daughter, and Levi's baby. And they did it under the order of, of the  
8 CPS, Idaho CPS and it's just sickening, sickening. And I-- I just got back, I'm pushing five o'clock  
9 and went to the hospital and they arrested me, and they arrested Wendy, my campaign manager.  
10 So I mean, it's just--I've never--I've lived in Nevada.

11 I've lived in Arizona, Utah, Minnesota, and you know, now here in Idaho. And I've never  
12 ever seen the wickedness that I've experienced here in Idaho and I, you know, I've seen a lot of  
13 wickedness. I spent two years in federal prison, never committed--convicted of a crime, never  
14 committed a crime and I've just never seen the wickedness, the willingness for law enforcement to  
15 just do whatever they're told. I mean, and, and, and just the, the wickedness I mean. I mean, even  
16 very liberal wicked states won't take babies away from their parents and, and there is not parents  
17 out there that love their child and take care of their child more than this little baby Cyrus. I mean,  
18 it's terrible, terrible. It started, you know, a week and a half ago, and he was dehydrated, and he  
19 was a little sick, and they were worried about him, he was just a little baby. So they took him into  
20 the hospital just being worried, and they brought him in, put him on an IV and he cleared up and  
21 did good. And then they wanted to take him from the hospital, and they were--the hospital were  
22 was kind of balking on it. Well, so they kind of put their foot down and then the doctor did release  
23 them. And then they started making them go to these weigh-ins. And this went on for several

1 days. And this morning, Marissa was feeling sick, and they were having just a lot of trouble and  
2 so they didn't make it to their weigh-in, their mandatory weigh-in and CPS ordered, ordered the  
3 Meridian police and police to, to take the baby away. And it's just wickedness. He's a healthy,  
4 happy, and he couldn't be loved more by, by parents.

5 We're in such terrible shape. The government can just take our babies away for any reason.  
6 It's just sickening, sickening, sickening. This is a healthy, happy, beautiful little baby with loving,  
7 loving parents, loving aunts and uncles, loving grandparents, grandma, grandpa. I mean, loving--  
8 everybody loves them. If it happened to the Chaboya [phonetic] family, it can happen to anybody.  
9 Everybody in Idaho knows them. I mean, I know that's an exaggeration, but they are so well loved.  
10 If it can happen to them, it can happen to any anybody. And it's just--it's a shame. It's shameful.  
11 The Meridian Police Department is a shame. They're shameful. CPS, Idaho CPS, is shameful.  
12 And anyway, it's terrible. They have that little baby now and won't let him go back to his parents.  
13 They arrested his mother because she wouldn't let go of him. So they arrested her for obstruction  
14 justice. They detained the father, they arrested the aunt. Then they arrested me at the hospital for  
15 demanding that they released that baby. They arrested my Wendy, my campaign manager but  
16 more importantly, my friend, roughed her up pretty good. And it's just, it's just wickedness, it's  
17 just wickedness. I don't know how--I mean, I don't know how we fix it. I don't know how we fix  
18 this. These people believe that they have the authority to take our little babies. They are wicked.  
19 And they don't think they are. They don't--they don't think they are. And this is--this is the problem  
20 I keep having with law enforcement.

21 I want to honor them, I want to respect them. I want to, you know, hold, hold them up.  
22 But I, I have such a hard time because there's so few of them out there that will do the right thing,  
23 that'll break rank. I've seen it one time in my life one time. That was actually Caldwell police. I




1 saw it one time and it was amazing. And all the rest, all this other time, I've never ever seen it.  
2 They always will follow orders and, and do what the institutions or the bureaucrats or, you know,  
3 tell them to do. That's what they'll do first. And they, they don't care about the people at all. The  
4 people are their enemies. And it's so hard and now this little family's suffering, and they're  
5 separated from their little baby, and they don't know when they're going to get back--get him back.  
6 And anyway, it's wicked. It's wicked. I'm tired. I'm tired. I've never seen such wickedness as  
7 here in Idaho. So anyway, I just had to get these things out and let you know what's happening.  
8 And tomorrow, we'll be gathering at the hospital. I'll send information out. Diego will send  
9 information out. We'll start to put a lot of pressure on these people. We need your help. We're  
10 going to need your help to make phone calls to the hospitals, to wherever CPS or wherever we can  
11 get. It's a weekend. So we're going to have to put a lot of pressure on them to let that little baby  
12 go. And we're going to need hundreds of people at the hospital. We can't let up on this. Diego  
13 has been, and his family are just wonderful, awesome people that have stood for people so many  
14 times and helped so many people everywhere, everywhere. This is what they do.

15 And so it's time for us to help them and even if they weren't that, we, we have to stand up  
16 and protect families and protect our little children. So anyway, I'll let you go and just wanted to  
17 let you know what's going on and made it home one more night. Wendy made it home. She's  
18 okay. She's kind of shaken and things are terrible, but we made it home and we'll be active  
19 tomorrow, trying to put pressure on the people that have caused this. And it is people that have  
20 caused it and shame on Meridian Police Department for, for enforcing this terrible so goodnight.

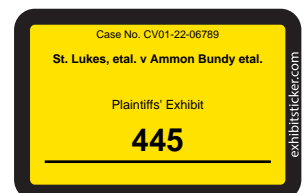

1 MR. JAMES WHITE: So we're headed to the hospital. It is about 11:30. We're going to  
2 start assembling at the hospital. So if you're here in Boise area, it's at 190 East Bannock, and it's  
3 St. Luke's there in Boise. They still have baby Cyrus, and he is, you know, still not with his mother  
4 and there is a few details that I wanted to share with you about last night, I was very tired when I  
5 spoke. I just want you to understand that about 10:30, I got a phone call from Cyrus's mother,  
6 Marissa, and she was in tears saying, they're trying to take my baby, they're trying to take my baby.  
7 And I began to, you know, talk her through this and, and help her be calm. And one of the things  
8 that I said to her is, you know, don't let them take him without you. And she says, okay, okay,  
9 okay.

10 Don't let them take him without you. Now, you have to understand, he, baby Cyrus has  
11 been healthy, but he's a little guy. And very, very common for, you know, children under one to  
12 be light. I mean, I know that my oldest and my third daughter was very, very little and lightweight,  
13 and in this situation, the doctors would've justified taking them away from me. So anyhow, it was  
14 important that Marissa stay with her baby, not only for, you know, because she's the mother, but  
15 also because she's breastfeeding. And that is where Cyrus gets his food from. He's been rejecting  
16 proteins. And so breastfeeding is where he gets his nutrition from, and that's what he needs. And  
17 so it was very important that this little mother stay with this baby. And I watched it on video where  
18 they were basically saying they were going to take the baby. And then ultimately, she held onto  
19 that baby with her hands and says, you just can't take it, you just can't take him, you can't take him,  
20 you can't take him. And they physically ripped that baby out of his mother's hands when his mother  
21 was more than willing to go with them and go get the baby weighed and have the baby checked  
22 out. And you have to remember, the only thing that happened here is they just didn't go to the  
23 appointment that the pediatrician set for them to have the baby weighed, they went the day before,

1 they went the day before that, they went the day before that. And Marissa was not feeling good  
2 that day. And so, I mean, is this where we're at, where the state can tell us that you have to go and  
3 keep a medical appointment, or you're going to be arrested, or your children are going to be taken  
4 from you? Is this where we're at?

5 We have to understand that what it all boils down to it is about who has the right to decide  
6 for that baby, and God gave those parents that right. And there was nothing that was causing that  
7 baby harm. That baby is a healthy, happy, and extremely loved baby. And so this cannot go on.  
8 It can't. It can't go on. We cannot stand around or stay home and allow the state to take babies  
9 from loving parents, healthy babies from loving parents. Now, what do you think is going to  
10 happen to that baby in the care of the state? They're saying that there's a hearing on Tuesday. That  
11 baby has been breastfeeding, that's what his source of food is and now the state is going to take it  
12 and try to give him what, some supplement or something else, who knows. He needs his mother.  
13 He needs his mother. He needs his mother badly and there's nothing better for that baby than to  
14 have his mother and his father loving him, his grandfather and grandmother loving him, aunts,  
15 uncles and friends loving him and it is not—there is no whatsoever right for the state to take that  
16 baby under these circumstances, none, none. There is no foul play, no abuse, no neglect, nothing  
17 but love, nothing but love. And the state does not have jurisdiction, even if the baby was, was not  
18 healthy, even if the baby was really seriously not healthy, the state still has no right to take that  
19 baby, none.

20 Now, just so you know, they have been taking the baby to a pediatrician, but this—this—  
21 the, the doctor from the hospital when they first went in, forced herself upon them and then began  
22 to force them to go to another pediatrician. It's just wrong all the way around. So we are headed  
23 to the hospital in Boise at 190 East Bannock. And also, we've asked people to send—call the




1 hospital, St. Luke's in Boise or Meridian, and call Meridian Police Department. There are links if

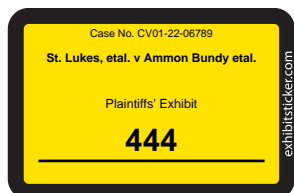

1 MR. JAMES WHITE: Needed to do an update for what's happening to the Chaboya  
2 [phonetic] family and, and baby Cyrus. I headed to the hospital again, and asking everybody else  
3 to go, we're get -- the family is going to have a press conference at 2 o'clock, so that's here in less  
4 than a half an hour. Just come down—you—even if you just got this message. So some updates.  
5 After denying that he was in that hospital, St. Luke's finally admitted that he was. They talked to  
6 the doctor yesterday and she gave him all the warm and fuzzes, gave the family all the warm and  
7 fuzzes that he was doing great. And then this morning, they got contacted saying that he hasn't  
8 been taking a bottle and that he is, you know, not getting the nutrition that he needs which has  
9 been the challenge that the family has had. So breastfeeding has always been the solution. And  
10 so he's been fine and growing, but he's been a little underweight, but he hasn't been able to take a  
11 bottle much and breastfeeding has been his food source. So anyway, they take the baby away from  
12 the mother, and of course, now they're having a hard time keeping this baby—nutrition in this  
13 baby. So again, they won't let the mother come in and breastfeed. They will not allow the mother  
14 to come in and breastfeed. She's literally outside the hospital, could come in and just breastfeed  
15 that baby and take care of it. So they're, they're talking about forcing a feeding tube down the baby  
16 so that they can feed it. And when the mother is literally outside, and this, you know, it—I'm  
17 pretty frustrated because there's people out there that are saying, you know, terrible things about  
18 this mother and she is one of the most wonderful people you'll ever meet. You know, anything  
19 from, you know, abuse, to drugs, those are all flat out 100% lies. This is a beautiful mother, this  
20 is her first baby. They did it right. They got married. The, the, the father works and provides for  
21 the family. They don't ask for anybody's help. Then they got, you know, wonderful support from  
22 grandpa and grandmother and aunts and uncles and friends. This is the, like, epitome of an  
23 American family, of how family should be. And the fact that they took this baby from this loving

1 mom and dad is atrocious, and then that somehow they're hyping something up like, and trying to  
2 justify themselves in this situation is disgusting. They need to get that baby back to their—back  
3 to that mother so that she could feed him and take care of him. And the state must yield on this.

4           And if we don't have some resolution very soon, baby Cyrus is going to be suffering. And  
5 we just can't let that happen. I don't know what level we're going to have to take this, but we have  
6 to make sure that we do what it takes to make sure that this does not continue much longer. I don't  
7 know if we're going to have to go to whatever level, but this can't go on, it can't. And this cannot  
8 be the normal in the United States of America where some liberal wacko doctor, literally liberal  
9 wacko doctor—well, he's not even a doctor. He's just like a glorified nurse. He's not even a doctor.

23 to get up? You are going to get dressed? Yeah, I'm calling you out. It's time to get out here and




1 to do some good. You can keep complaining. You could say that, you know, the one world order's

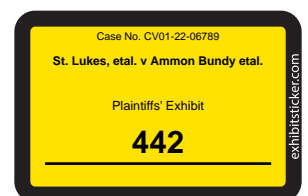

1 MR. AMMON BUNDY: Hey long day, but I needed to once again give you another  
2 update. We've been pushing hard and we got them to let the mother and father see Baby Cyrus,  
3 Marissa [phonetic] and Levi [phonetic]. And they got in there, which is actually amazing because  
4 this is a weekend and this is CPS and they typically don't do that. So we know that all the calls and  
5 being at the hospital and all the things that are going on are working. So they've got to a visit, but  
6 when they got in there and they got to see Baby Cyrus exactly what makes sense, right? They took  
7 him away from his mother she has been his source of food, like - - Nature made it that way. He's  
8 had trouble eating solid foods and so breast feeding has been his way of being fed. He doesn't take  
9 a bottle very well and so when they get in to see him, he is not looking very good. He is not and  
10 it is extremely concerning to his mother and his father and his family. He hasn't, you know, eaten  
11 and he hasn't gone to the bathroom, he hasn't pooped and since he's been in there and he—they are

13 And the hospital has literally ripped the two individuals. His mother and father have been  
14 taking care of him so well away from him and somehow think that they're going to take care of  
15 him better and he needs to be with his mother full-time under their custody. His mother needs to  
16 be feeding him the way that they've been doing it since he was born. And one thing that  
17 representative Judy Boyle brought up today in the press conference—by the way, if you haven't  
18 seen that, you should go, go watch that. I'll try to link it here as well. But she said that any  
19 mother—first time mother and I know this and all you mothers out there know, and fathers that  
20 hopefully are involved know that a first-time mother, that breastfeeds is extremely difficult. It's  
21 difficult all the time, but extremely difficult for a first-time mother. And for a mother to do that  
22 shows—for a mother to do that shows that they love their child and that they want the best for their  
23 child because they're willing to sacrifice and go through all of that.

1 Well, Marissa the mother has been doing that and she, she is a wonderful mother. She is a  
2 beautiful per person. And she loves and has taken care of that—this family is such a beautiful  
3 family the Chavaya family is a family that truly can be used an exam—as an example for the rest  
4 of the world of how family should be. And the fact that they somehow are accusing this family of  
5 not taking care of their child is absolutely a terrible misjudgment if—and that's saying it a nice  
6 way.

7 So we must, we must get this little baby back to his mother and get him to where he is safe  
8 and eating and doing the things that cannot be done in the hospital unless the mother's there. That,  
9 that Marissa needs to be with her child all the time. That child needs to be in the custody of their,

11 any other baby. And so this idea that somehow just letting the mother come and visit the baby for  
12 two hours is, is being benevolent. That is not the case that is not benevolence that is control. This  
13 baby needs to be returned immediately to her mother and father or his mother and father.

14 Now, there have been people that have wanted to come and support and I am asking you  
15 to do that all over—all over the country this is something that is very serious and it is escalating,  
16 and this little baby possibly could lose its life because of the decisions of people who don't even  
17 care about that baby that just want to exercise authority. Anyway, I, again encourage you to go to  
18 the press conference and watch what was said there because this is an atrocity the details were  
19 given in that press conference and details that are indisputable about this case and we need you to  
20 come, we are doing something that is going—is bringing a ton of pressure to them and one of the  
21 reasons why we believe that they're starting to loosen up and, and let the parents, you know, visit  
22 them.

1           We are going to the doctor who issued this order to CPS we're going to we're—we've been  
2 at his house all day today. Well, most of the day we're going to be there between 8:00 a.m. or  
3 10:00 a.m. and 8:00 p.m. We're also have been at the officer's house who ripped this baby away  
4 from his loving mother and some of the things that he said are just disgusting and like, just give  
5 me the baby and go back to your life that's what, that's what he said to her when, when he took the  
6 baby and his name is Steve Hansen [phonetic] and he lives in Nampa. And so we are, we are also  
7 staying at his house between 10:00 a.m. and 8:00 p.m. every day until Cyrus gets home. The  
8 doctor's name was Aaron Dykstra. I said it wrong earlier, so I'm—now need to say it right,  
9 Dykstra, and he's in Middleton. His address is 1084 La Reata Way—1084 La Reata Way in  
10 Middleton, Idaho.

11           And the officer's house his name is Steve Hanson, is 6-0-9-1, 6091 East Path Drive in  
12 Nampa. And then of course, we are going to have a presence between 10:00 a.m. and 8:00 p.m.  
13 at Boise St. Luke's Hospital so they know that we're there. And then we also are going to have a  
14 press conference while the family's calling. This is nothing that, you know, I'm doing. This is the

23 them that this is not something that is acceptable.



1           We should have hundreds, if not thousands of people at this press conference tomorrow at  
2 five, five o'clock at Boise St. Luke's. People have asked me from all over the country if they  
3 should come the answer is yes. People are coming from all over the state, up north, out east, all  
4 over. I've talked to—and yes, you should come. This is a situation that is serious enough that you  
5 should come. I will say this, the family truly needs you to support them they truly need you to  
6 support them and I know that if the people will respond as they have been, that we will be able to  
7 resolve this issue. How do I know that? I have seen this many, many times before. This works if  
8 people respond and we will continue to escalate this as far as we need to. We will do whatever it  
9 takes in order to get this baby home. And it's going to have to happen fairly quickly because Baby  
10 Cyrus is losing more weight and becoming more sickly because the hospital will not let his mother  
11 feed him and let his family take care of him.

12           And they, they know that they—they've been doing this for a long time and he—they've  
13 kept him healthy. Yeah, he's a little guy. They've kept him healthy and he—and happy, I've seen  
14 him many times. He's a little guy. But I had a daughter that was born six pounds, 14 ounces, and  
15 she was—when she was two years old, she was wearing a month—10-month-old clothes. And so,  
16 and she was healthy. She's a feisty, healthy little thing. I know that this happens and in that  
17 scenario with my daughter, under these conditions, they, they would, they would justify taking my  
18 daughter. And my daughter was never unhealthy. But what they're doing to them now and taking  
19 him away from his mother where he can't breastfeed now, that's abuse. And we will not tolerate  
20 that. We will not tolerate. Yeah, we'll go through the processes we have to, we'll do whatever  
21 thing. We'll, we'll do whatever we have to do right now to unite, to put pressure on them, but we  
22 will continue to escalate this until that baby is with his mother where he should be and rightfully  
23 should be.

1           So anyway, thank you for your support continue to do it I'm going to give these addresses  
2 one more time. And also, I wanted to mention something very important, and I almost forgot one  
3 of the reasons why I did this whole video is tomorrow at noon, they're also going to the doctor's

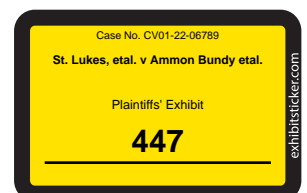

1 MR. JAMES WHITE: So it's a very sobering morning to—this morning today. Baby  
2 Cyrus is still in the Luke Boise, St. Luke's Hospital, still being held away from his mother. They  
3 have had two visits in the last four or five days and that's the situation. Today is a hearing, they  
4 have it at 1 o'clock, this is with a CPS administrative judge. And I've talked to a lot of people that  
5 are very involved in CPS because they had their children taken, or they've been fighting for other  
6 people and helping other people, and they've all—the ones I've talked to, only one has seen the  
7 baby be released home to its parents one time during this hearing. All the rest of the time, they  
8 find a replacement place for the parents or for the child, foster home and then it's about a month  
9 or so, and they have another hearing. And so this hearing is very important to get baby Cyrus  
10 home, it's important for his health, it's important for his care, and it's important for all of us because  
11 we cannot let this be the normal.

12 So we need people to go to the Ada County Courthouse at 1:00 p.m. today or about 12:30  
13 p.m. and to fill the courtyard so that these people know that what they're doing is terrible. Now, I  
14 have to say that I'm not okay with any of this. To be honest with you, if justice was to be served,  
15 we would go into that hospital, take that baby, and we'd give it back to their mother. And then if  
16 we are further to administrate justice, we would find those that were accountable and we would  
17 prosecute them and make them pay for the damages that they've caused to this family and assure  
18 that this never happens again. That's what should happen. And I will say this, that I'm a not, not  
19 alone in those, those feelings, but we also have had to suppress those, those thoughts and actions  
20 because we are trying to give the people that are making the decisions, that are doing this thing to  
21 them, give them a chance to correct this issue so we don't have to do it for them. Now, I will say  
22 this, we've been at the Boise St. Luke's Hospital, between 10:00 p.m. to 8:00 p.m.—excuse me,

10 presence there. I promise you, there is no way whatsoever that this is not going to put a ton of  
11 ache on a lot of people's face because this family is a beautiful, wonderful family that has always  
12 cared for this baby and this is not about neglect or abuse, and there was no reason whatsoever at  
13 all in any way that the state should have taken that baby away or has any type of justification, no  
14 matter, no, no what, no—in this case, there is no justification, none and they did it anyway. So I  
15 will say again to all of you that are out there, I know that there are groups, patriot groups that have  
16 wanted to come and just do what needs to be done and I have been kind of holding the flood gates  
17 from that happening, trying to make sure you guys don't do that yet. Because I believe that we  
18 have a chance here today to get this straightened out, and if not, then I can't hold you back from  
19 what you're going to do. That Judge would be culpable, he's probably the same one that signed

22 separate them.




1           And most of the time, when they do it, it makes no sense at all. Well, a lot of the time

14 sometime to correct their actions, return that baby back to the—to his beautiful mother, and that  
15 little beautiful baby united with their family is what our desire is. So again, that's my call to action  
16 and update here this morning, this rainy morning here, here in Idaho. Thank you.

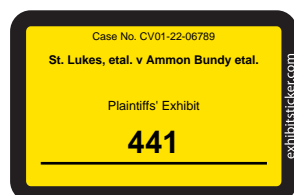

1           MR. AMMON BUNDY: Double source that the CPS is going to take Cyrus while we're

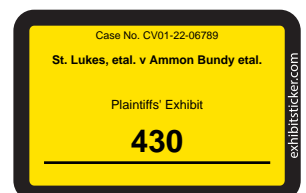

1 MR. AMMON BUNDY: I'm just getting home. I'm still in my truck trying to process this  
2 day. I know people need some instruction or at least some information, and that's what I'm trying  
3 to do here. As you know the judge had a hearing and oh man, just crazy what happened? Huh,  
4 where do I begin? I can't believe what's going on. I've never seen such wickedness, and so it's  
5 hard to describe. And, and I can't believe that it's—it truly is you know, good being called evil  
6 and evil being called good. You got these little parents that love this little baby, and I mean, they,  
7 they couldn't be better parents. They're, they're just—I mean, they're perfect little parents and they  
8 got this little baby, and I mean, I don't need to reiterate it, but just seems like no one—I mean, not  
9 no one, it's not fair to say that.

10 It just seems like so many people don't get it, that they just believe the state, that there's no  
11 way the state would take a child. But yet this judge, Judge Laurie Fortier we're doing a, you know,  
12 looking into her and she's taken hundreds of children and she's done it with this doctor, Natasha  
13 D. Erickson, here in Idaho. And these doctors work in conjunction with CPS and, and with these  
14 judges. This Laurie Fortier is, you know, she's—I mean, I can't believe what, what she was saying  
15 and what the attorneys were just expressing a little bit.

16 They weren't giving any details, but just expressing what happened. And, and my jaw  
17 drops. I, I can't believe it. And then I hear the details from, from the family. And anyway, they  
18 took the baby and put him in another home. So put him in another home. You know, the doctors  
19 said that, you know, he's healthy and he's healthy enough to go into another home, foster home,  
20 but, but the judge won't let him go home, won't let him go. And so they have a another hearing on  
21 April 8th, you know, almost a month away. And if they can't get him back then, then there'll be  
22 another hearing in six months.

1           If they can't get him back, then there'll be another hearing in 12 months after that, or, or six  
2 months after that. So a year from, from today. And then they could put him in, you know, up for  
3 adoption. So that's the process. And it happens, you know, all the time. And what's amazing here  
4 is the only thing that happened was they missed an appointment just to get him weighed. That's  
5 the only accusation that the state has against this little family. You know, there is no neglect, there  
6 is no abuse, none of that. In fact, there's—they got a perfect record. The only thing that the, the,  
7 the—or the state is saying, the CPS is saying that they did is missed away an appointment. And  
8 the mother called in. And one other interesting fact, I mean, there's so many, but you know, on  
9 the medical forms, it says because they said that they, they tried to get ahold of the mother multiple  
10 times to get him to come in.

15 On the Lookout. When they locate the vehicle, they surround them at the gas station, ripped the  
16 kid—ripped the baby away from the mother's arms, and now they don't have a baby anymore. And  
17 that baby was their entire life. So what are we going to do about it? I don't know. I don't know.  
18 I just needed to give you an update that they took the baby and gave them to another family. That  
19 the, you know, Cyrus's mom and dad and aunt and uncles and grandma and grandpa are, are just  
20 trying to process this. And that's why they haven't made a statement. And, and I was with them.  
21 So I know.

22           And I am—I'm a little, you know, a little discouraged by how many people out there are  
23 believing that the parents did something wrong. But look at the evidence, there is no evidence just

1 because somebody says something, you know, the police say he was malnourished. That's a lie.  
2 There is no evidence of malnutrition. You know, two weeks ago he went and took him into the  
3 hospital because he was throwing up because they couldn't give him solids and he threw up a lot  
4 and they were worried about him being dehydrated, you know, so they took him to the hospital.  
5 That's being a good parent, supposedly. But the lesson we learn here is that you don't—don't take  
6 your kids to the hospital, you know, don't take your loved one to, to the hospital. You, you can't  
7 afford it. Your kids not just afforded by money. You will—you—there's a good chance that the  
8 state will get involved if you take your child to the hospital. This just proves it.


9 So, I mean, I don't know if—what, what else motive there is. I mean, you know, there's

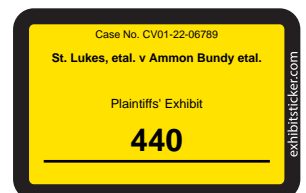

1 MR. AMMON BUNDY: Very, very exciting news. Baby Cyrus was returned home. He  
2 is now home with his mother, and he couldn't be loved more. There was no reason to take him in  
3 the first place, so I'm not going to try to, try to make sense of what happened. It just is a wonderful,  
4 beautiful thing that he is home with his mother and his father and his family that love him so much.  
5 This little guy is loved so much. If they're not careful, he's going to, he's going to grow up thinking  
6 he's the only person in the world that matters. But he—anyway, it's been so beautiful to see and to  
7 be with him. And, and I want to thank all of you who did your part and we're willing to do whatever  
8 it takes to get this baby home.

23 CPS and it—a lot of it is caused because of your statutory laws. And there is no way a judge


1 should arbitrarily be able to take a child away from their parents. If there is a need for the state to

1 MR. AMMON BUNDY: Hey, there. I'm going to try something that I haven't tried for  
2 quite some time and that is just to talk to you and just—I have some things on my mind. I've  
3 thought about doing this more often, about just kind of taking a topic, something that's happening  
4 and just fleshing it out. So we'll see what happens. I want to talk today about; St. Luke's Hospital  
5 is suing me and why I haven't been participating in the court process.

6 You might have seen in the news yesterday that I—that I had a hearing, it was like some—  
7 I don't know, a hearing where the St. Luke's was trying to get the judge to find me in contempt, or  
8 something to that effect. So anyway, I'll give people a few minutes to get on here before I get  
9 going into some of the meat of this.

10 But St. Luke's Hospital is suing me, also is suing Diego Rodriguez and they're suing my  
11 campaign, Ammon Bundy for Governor, and they're suing People's Rights as well and, I think,  
12 Diego's marketing company. And it is over this Baby Cyrus case. And if you remember what  
13 happened, so I'll kind of break this down.

14 Baby Cyrus is the grandson of Diego Rodriguez who's a good friend of mine. And we've  
15 been very vocal about what Governor Little is doing and how—the things he did by locking the  
16 state down and now he's lying about a surplus and about how he didn't lock Idaho down and all  
17 these other things. So we've been very vocal about that and that's put a target on our back.

18 And Diego's grandson, Cyrus—Baby Cyrus his parents, Levi [phonetic] and Marissa  
19 [phonetic], took Baby Cyrus into St. Luke's Hospital because they had basically started introducing  
20 solid foods to Baby Cyrus and he wasn't doing well with it. He was doing fine with breastfeeding,  
21 but as soon as they started introducing solids, he wasn't doing good with it and it would cause him  
22 to start to vomit. And he would go into spells of vomiting and then he would get dehydrated. So  
23 they were worried about him and they took him to the hospital because they were afraid that he

1 was too dehydrated because he had a pretty good spell of vomiting. And of course, when this had  
2 happened, they'd put him back on breast milk and he'd be just fine. And when they get in there,  
3 they weigh Baby Cyrus and they begin to automatically act. And they look at, you know, Baby  
4 Cyrus wasn't vaccinated and, and who knows what else they look at.

5 But all of a sudden now, in my opinion, they look at the parents, Levi and Marissa, who  
6 are just wonderful, wonderful people. I mean, amazing, good, honest people. This is their first  
7 baby. They look at them as enemies for some reason or somehow like they're doing something  
8 wrong because they're not following the typical protocol of what the hospitals and what the general  
9 society believes they should be following.

10 So they began immediately to kind of have this undertone of threatening the family because  
11 Baby Cyrus is a little, like a few ounces, underneath the weight—the recommended weight. Well,  
12 I have to say, I could lose a few pounds. There's no doubt about that. I could lose—I could  
13 probably lose 20, 30 pounds and be in pretty good shape. But right now, I weigh more than both  
14 Marissa and Levi together because they're just little people, little skinny people, beautiful people.  
15 I mean, they look like models, they're awesome. But they're just little people and they probably  
16 together add up to about what I weigh as one person. So of course, their kids are going to be little  
17 and Baby Cyrus is a little guy.

18 They go in the hospital and now they have this box, this checkbox that if he's not the weight  
19 that they say he's supposed to be, no matter what genetics are or anything, then all of a sudden  
20 now, he's under threat of life to thrive or thriving. And it's just ridiculous. It's absolutely  
21 ridiculous. And so, Cyrus—or Marissa and Levi were kind of like confused. They didn't feel  
22 right. They knew something wasn't right. They pushed to get out of the hospital, then they  
23 threatened if they did, that they would call CPS, so that they said, "Okay, don't call, you know,

1 there's no reason to go there. We'll stay one more day." And they stayed one more day and then  
2 the hospital couldn't find anything wrong with him. Never had an issue. I guess he got hydrated  
3 and then they left the hospital.

4 But they wanted them to go back to an appointment with the doctor and do weigh-ins and  
5 they basically said, "If you don't do this, we're going to call CPS." It was all under threat of CPS.  
6 And so, I think, the next Monday—and I might have my days mixed up and all, but these are the  
7 facts. And so, it might've been the next Monday, I think there was a weekend in between, they go  
8 to the weigh-in appointment and they do that appointment and they do another one, I think, the  
9 next day. And then I think they might've even done a third one. And then on the fourth one—and  
10 again, don't—these facts, they might be as far as like days or weekends and so forth. They might  
11 be a little wrong, but this is what happened.

12 And so, they wake up the next morning and they have an appointment for a weigh-in.  
13 Imagine, they have to do this now every day or they're threatened that their baby's going to be  
14 taken from them. These parents are the most loving parents you could find. They love this baby.  
15 In fact, I'm afraid this baby is going to be spoiled when he grows up because he's the first grandson,  
16 he's got loving aunts and uncles and their parents love him so much. And he is a cute little guy,  
17 so he's not hard to love. And he gets so much attention and love that he's probably going to be  
18 spoiled. He probably doesn't need so much love and attention, to be honest with you. I can't  
19 believe I'm saying that, but he is. He's very loved and that's the point I'm trying to make.

20 And so, they get up, well, Marissa doesn't feel well. So they call into the doctor's office to  
21 say that, "We're not going to make it." No one was there, they just left a message. I don't know if  
22 it was before the opening or whatever, but they leave a message. And then, next thing they know

1 is—and I know there was—the doctors tried to reach out to them and I don't think they made  
2 connection, amongst other things, but either way, the doctor then called CPS.

3 And the next thing you know, knocking on Diego's door, actually, are two police officers  
4 demanding that they see Baby Cyrus. Remember there was never anything ever found wrong with  
5 Baby Cyrus. And he was loved, there was never accusations of neglect, none of that. This was  
6 just—at this point, this was just them doing their thing.

7 And so, they send these officers, they weren't in uniform either, knocking on the door, and  
8 they inquire, and basically, Diego says they're not here, which they weren't there. And they lied  
9 about that later in their report. They said that they were there and they weren't. They were not  
10 there. Baby Cyrus was not there. Levi and Marissa were not there. And they tried to get in and  
11 Diego's like, "No, you're not going to search my house," whatever. And so, they leave. And then,  
12 they put what they call—I can't remember exactly what it is right now, it's an acronym, where they  
13 put them on the lookout, Be on the Lookout. And it's a BOLO, Be on the Lookout, that's what it  
14 is, a BOLO, and basically, for Levi and Marissa's truck.

15 Well, Levi, Marissa, the aunts and uncles, Diego and his wife, they all go to a friend's house  
16 for dinner that night. Not thinking much about it, thinking other than the visit from the police was  
17 weird. And on the—by the way, that friend is a ex-police officer that retired out of California and  
18 moved here. So it's not like there's contempt for the police or anything like that. They were  
19 actually having dinner at a retired police officer's house. And he's a good friend of theirs.

20 So they leave that—his house. It's probably like 10 o'clock, 10:30 or so, when they're  
21 driving home. And they get pulled over, because of this BOLO, in Meridian or close to Meridian,  
22 and they're at a gas station, the Chevron gas station. And I'm not kidding you, there ends up being  
23 probably, I would say, according to the video, it's got to be close to 20 officers that surround them.

1 And it's disgusting. I encourage you to go to [freedomandpress.org](http://freedomandpress.org), I think it is, [freedomandpress](http://freedomandpress.org)  
2 or [freedomand.org](http://freedomand.org). And there's videos there, the way that these officers are acting. In fact, it  
3 makes me so upset and so bothered that I'm surprised that these officers haven't been shot acting  
4 like this. That people just haven't lost their minds to the point where they're not going to put up  
5 with this type of activity and just do open violence against them. And I'm not promoting that. In  
6 fact, I'm just opposite of that. That's what I've tried to prevent by doing what I've done. But the  
7 way these officers acted is just about justification for taking their lives. And it's very sickening.

8 And ultimately, they falsely accused the aunt. They think she's the mother. They drag her  
9 out of the vehicle. They handcuff her, slam her against the car. They slam the father, they  
10 handcuffs him - - against the car. And then they finally figure out that the mother is in the backseat  
11 with Baby Cyrus. And they con her into—and they say that she can go with them to the hospital.  
12 They're just going to do a checkup. And they con her into the ambulance and then rip Baby Cyrus  
13 out of the mother's hands, and then handcuff and arrest the mother for obstruction of justice. And  
14 I mean, it's really sickening. You've got to go to [freedomandpress.org](http://freedomandpress.org) or [freedomand.org](http://freedomand.org). You've  
15 got to go watch those videos. You'll see that—you'll have to navigate. I don't know where to  
16 navigate. You'll see them. It's sickening. It's sickening. And it's extremely bothersome that these  
17 police officers are doing this. And they're still today active police officers and never been in any  
18 way reprimanded. Nothing. So anyhow, this goes on.

19 Well, during this process—this is kind of where I come in—during this process, Marissa,  
20 the mother calls me and she can't get ahold of me on my phone. It's after—this is like close to 11  
21 o'clock. So she calls my wife. My wife immediately comes in and we're on FaceTime. So we're  
22 hearing and watching this whole thing. And I'm like trying to guide her through it the best. I'm  
23 like—the main advice I told her is, "Go with the baby. Make sure you go with the baby. Go with

1 Baby Cyrus. Do not let them take Baby Cyrus without you. You are a nursing mother. He is  
2 having trouble with any type of other foods. He needs you. He needs you to nurse him. He needs  
3 you to care for him. He needs you. He's already a little guy. He needs you. Make sure you go  
4 with him. You have a right to go with him. You are the mother. You have done nothing wrong.  
5 Make sure you go with him."

6 And so, she was doing her best and really did an amazing job in this video to try to stay  
7 with her little baby, 10-month-old little guy, sweet little thing. And they rip the baby out of her  
8 hands, handcuff her and book her in the Ada County jail. Just pure wickedness, pure wickedness.  
9 And no one—I don't see how any mother or any father could condone what these police officers  
10 did. I do not. I think if you condone what they did, you have such an extreme bias that your  
11 children are probably in danger because you would put the state in front of your own children.  
12 Otherwise, you can't condone what these officers did. It's a terrible thing. And the way they did  
13 it with the contempt and the force is just sickening, sickening. They should be ashamed of  
14 themselves, completely ashamed of themselves.

15 So anyhow, because of all this, I'm aware of what's happening. And they tell me that they  
16 put him in the hospital—or in the ambulance. And of course, they're not going to tell. And I just  
17 kind of feel or kind of sense that they're going to take him to St. Luke's in Meridian. And so, I get  
18 in my vehicle—I'm in Emmett. I get in my vehicle and I start to head there, but I don't go to the  
19 Chevron gas station. I'm headed to St. Luke's hospital in Meridian, just kind of on an instinct that  
20 that's where they're going to end up.

21 Well, I get there about right after, like just minutes after the ambulance gets there. And  
22 this is the sickening thing; so I get there—and we didn't know any of this, but the plan was—and  
23 this is all in the court documents, you could look it up. I could show you, it's all in the court

1 documents. But they weren't taking him to the hospital to get checked out. They had another  
2 family there, that they were going to take him out of the ambulance, give him to another family so  
3 that they can go take him to another home. And that's exactly what happened. Well, that was  
4 going to happen. It's clear in the documentation that they weren't there because they were worried  
5 about Baby Cyrus's health, necessarily. They wasn't there to—in the hospital to make sure that he  
6 was okay. That was the transfer of taking that child from his mother and father and giving him to  
7 another man and woman, or whatever it was, family, to take home right from the ambulance.

8 Well, because we showed up there and we made such a big stink about it, demanding that  
9 they give that baby back to their parents who love and care for them, they decided that it was too  
10 risky to give the baby—Baby Cyrus to this family, that it would be putting them at risk and it was,  
11 you know, all of these things.

12 So they ended up keeping Baby Cyrus and they took him to the hospital in Boise, St. Luke's  
13 hospital in Boise, and we followed them. So we had really good—I had people following them.  
14 And I was there, of course, at the Meridian hospital, but we ended up following the ambulances.  
15 There were several and we had them followed and we ultimately made the conclusion, which we  
16 were right, that Baby Cyrus ended up at St. Luke's hospital in Boise. However, I was there  
17 basically telling these officers what—that what they're doing is so wrong and they need to give  
18 that baby back, and all for it, they just snuck up and arrested me. Now, to be fair to the situation,  
19 the hospital asked us to leave the ambulance bay area and step back, but they never asked us to  
20 leave the property and they trespassed me. And the claim is that—the claim is that they told me  
21 to leave the property and that's just not what happened.

22 Anyway, they arrested me, took me to Ada County jail and booked me in and I bailed out.  
23 And I was in there with Miranda [phonetic], the aunt, Marissa, the mother. I was in there with my



1 campaign manager because she got arrested too, just for being there, just to make sure. And also,  
2 of course, I was there. I mean, so the mother and the aunt is also being booked in the jail right in  
3 front of us and this is the situation.

4 So anyhow—so I was given—now, just so you know, they dropped the charges on the aunt  
5 because they completely falsely charged her and they dropped the entire CPS case. So they said,  
6 "Hey, this wasn't right." That's ultimately what they were saying, "This wasn't right, but so we're  
7 dismissing it." But they haven't dropped the obstruction of justice charges on the mother, okay on  
8 Marissa. And of course, they didn't drop charges on my campaign manager, Wendy [phonetic], or  
9 on me, for trespassing. So they continue to prosecute us. Now, that is how this all came about as  
10 far as the trespassing charges and those are criminal charges.

11 And so, I have been participating in this process and it's, you know, basically I hired a  
12 couple of lawyers and they've been kind of going through the process until we get to trial. And I  
13 have been defending myself because on a civil case, if you don't show up, that it's failure to appear  
14 and they send the sheriff after you or whatever, and they arrest you for failure to appear. And then  
15 there's all of that. So I've been participating in that process, although I don't believe that I'm going  
16 to get any type of justice with an Ada County jury.

17 Now, there are some conservatives in Ada County and this is a heartfelt thing when it  
18 comes to parents. But I don't know if they can put aside their contempt for me because they're—  
19 most of them are liberal minded, they have a leftist ideology. And I'm enemy number one in Idaho,  
20 so they just hate me. And I've seen that in several trials that I've been in.

21 So anyhow, what happened is, then the next day I began to push and I began to rally people  
22 to come to the hospital in Boise. It wasn't just me. Diego was using his influence; other people  
23 were blasting it out. But I was blasting it out and through my campaign and also through People's

1 Rights to come to the hospital, that this is wrong. And I just want to give you a little perspective;  
2 there's this type of thing, if you will, and you have to—I mean, you just have to think about the  
3 practicality of what just happened. They stole a baby from loving parents with no justification,  
4 really no excuse actually at all. Never once did they say that they could find anything wrong with  
5 Baby Cyrus. Never. But they justified taking Baby Cyrus from loving parents and then actually  
6 giving him to another family.

7 Now, so I ended up the next morning, with about 400 people, in front of St. Luke's hospital  
8 in Boise. So we're talking about no sleep, no nothing, right? We're there, I think, 9 o'clock in the  
9 morning. We're there and there's 400 people and we have a press conference. And I've done this  
10 type of thing several times and Diego's a great spokesman, extremely capable person. And they  
11 still have his grandson in the hospital. And so anyway, we began to put this ton of political  
12 pressure, all the influence that we have nationwide and began to put all this pressure on them. But  
13 Diego was mostly the spokesman; I did a few videos and so forth. Diego was mostly the  
14 spokesman.

15 And ultimately, St. Luke's hospital was like, "We don't want Baby Cyrus anymore." And  
16 the CPS agents were like, "We don't want him anymore." He was like a hot potato. And so finally,  
17 after an unprecedented short amount of time, they call the family up and say, "Hey, come get Baby  
18 Cyrus." And they went and got him. It was six days. Typically, it takes a couple of months for  
19 this process to happen, to get the baby back. And so—and I've been told by—this by many, many  
20 people. So I'm not an expert of CPS, but I've been told this situation doesn't happen fast to be able  
21 to get babies back. And it did happen, six days is still a long time. The health of Baby Cyrus was  
22 very concerning. They didn't let him breastfeed for like three days until they were afraid that Baby  
23 Cyrus was on the verge of, like, death. And I do believe he was on the verge of death. They finally

1 let Marissa come in and breastfeed after three days, but they still wouldn't let Baby Cyrus come  
2 home.

3 And finally, six days, we get him back, we celebrate. And we put a ton of pressure on CPS,  
4 actual agents, the judge, the doctors. And I mean, because I believe in personal accountability.  
5 It's the only way to get people to change their direction. You can't do it any other way. There has  
6 to be personal accountability. You have to feel accountable personally. And so that's what we do.  
7 And that's why I do it. And so, and it works. I've done it many, many times. It works. I'll continue  
8 to do it. And I mean what I say, when I do it, I'm not just trying to bluff somebody.

9 Now, there's some other pieces that maybe I'll talk about, about what was happening in the  
10 background because I was really holding a tremendous amount of Patriots back from coming from  
11 all over the country, that were wanting to basically clean house, clean—because this was wrong.

12 And let me put this in perspective; one of the most insulting things that Native Americans  
13 would do—one tribe would do to another, is steal one of their babies and then take and try to raise  
14 them in another. It caused wars. It was extremely—it was like the ultimate insult to—from one  
15 tribe to the other. And ultimately that's what has happened here. And people saw and recognized  
16 what was going on. They saw how the political ties, the connections between Governor Little, St.  
17 Luke's, myself and Diego, they saw—they all saw this.

18 But then just the pure, what do I say, wickedness of this, just that pure wickedness. And  
19 they were going to come, they were asking me and indicating through other means of  
20 communication. And I was getting this feedback that they were planning on coming to Boise and  
21 doing whatever it took to get the situation worked out. And I kept saying, "No, no, don't come yet.  
22 Let us try to go through this process. Give us a little bit of time to try to put political pressure on  
23 it. Don't come in and just wipe out something like madmen. Let's try to get this done right."

1 Although I completely believe that they were justified in it. I really do. However, I felt it wasn't  
2 the most prudent thing.

3 And so, we did our thing. We put pressure on the right—in the right places and ultimately,  
4 they finally, you know, pretty quickly realized this—what was happening, that it was just going to  
5 keep growing and they gave Baby Cyrus back. And then a few weeks later, they dismissed the  
6 case and dropped the charges on the aunt, Miranda, but didn't—hasn't—haven't yet dropped the  
7 charges on the mother.

8 So anyway, we have a great victory, right? We've got Baby Cyrus back. The case is  
9 dropped. It's a great victory. And we go back to life. I go back to campaigning. I took three  
10 weeks off during—it was very difficult because we had to completely just clear our schedule and  
11 our itinerary. And I just felt like I had to do this. I couldn't campaign while this little baby was  
12 being taken and away from this family's hands.

13 And so, I went back to campaigning and then shortly after that I find out through the,  
14 through the—actually, through the media that St. Luke's is suing me and they're suing me for  
15 defamation. And I just thought, wow, this is a perfect example of evil being called good and good  
16 being called evil, because here, these people stole a baby from loving parents. And it's pretty much  
17 through their dismissal of the case and dropping—giving Baby Cyrus back and everything, has  
18 pretty much acknowledged that it was a wrongful act to take a baby. And us, who stood up and  
19 exposed that, that they now sue us.

20 Now, they're suing me and Diego for defamation. They're saying that we defamed them.  
21 And the one thing I will say is that everything I said, everything I said, I believed. And everything  
22 I said, I believe, still today, to be absolutely accurate and true. There's only one little piece when  
23 I said that—in one of my videos, I said that the doctors and the judge have done this hundreds of

1 times. Now, I believe that. I do believe that. I look at their workload. I look at CPS. I look at  
2 how they work together. I do believe that. However, that is one thing that I don't know for sure.  
3 But I did say that. But I still believe that. I believe that if we were to look into the evidence of  
4 that, that I could prove that statement. However, I don't know for sure. So that would be the only  
5 thing that might be in question, of me saying something that was not absolutely accurate, but I still  
6 believe.

7 And now, what they're saying is that we did this to get financial gain because you can't sue  
8 someone for defamation unless there's some type of gain. Like a corporation gains by defaming  
9 another corporation. So there has to be that element. So they're saying that we did this to get  
10 public support, to get donations, and they defamed and caused St. Luke's to lose money. And  
11 actually, it's not just St. Luke's. It's actually the CEO of St. Luke's that is personally suing us, St.  
12 Luke's and then one of the doctors.

13 Now I just want to give you an—St. Luke's claims to be a nonprofit organization, right?  
14 They claim that. Yet the CEO who is suing me, the CEO of St. Luke's makes \$18.2 million a year.  
15 Yes, that's \$18.2 million a year. And I believe that benefits and bonuses are on top of that. I don't  
16 know exact for sure. I'm certain benefits are, but his paycheck is \$18.2 million. I did the math,  
17 it's like over \$1,400 an hour that he makes. And he's suing me, saying that somehow, I caused him  
18 financial harm and St. Luke's as well.

19 And so, this lawsuit came across and there's all kinds of just crazy false accusations and  
20 saying we did this. And about 90% of the accusations are just flat, unfactual [sic]. They're not  
21 even, they're not even factual. Then the others they've tied with facts, but they're aligned  
22 incorrectly to make—to create a narrative that's not correct. So that's what they're doing.

1           And I had to make a decision. Like, here I am, I just took three weeks off the campaign  
2 and fighting lawsuits. And in the courts, I'm already fighting my trespass case, right? Because I  
3 have to. And I had to make a decision after much prayer and contemplating like, can I spend tens  
4 of thousands of more dollars trying to defend myself and hundreds of hours in the middle of this  
5 campaign it'll completely distract me from the campaign. And I believe that the campaign, running  
6 for governor, is more important than allowing myself to be distracted into these courts where I was  
7 spending all my extra time trying to defend myself and all—and my extra money trying to pay for  
8 attorneys and legal fees to defend myself as well.

9           And I began to basically weigh this and look at my options. And I decided that the best  
10 way—the best course, because of the circumstance, is to just allow the court to go do their thing,  
11 allow these guys to do their thing. And ultimately, the judge, because it's a civil case, will order a  
12 default judgment against me, and then St. Luke's will try to collect—they say it starts at \$75,000.  
13 So they'll try to collect \$75,000 from me, People's Rights and Ammon Bundy for Governor  
14 campaign. But the campaign is going to be over. They're not going to be able to collect on that.  
15 People's Rights isn't an entity. It's a network. It's a network of people. It's not a legal entity. So  
16 they can't collect from that. And so, they may be able to try to get a judgment—they'll get a  
17 judgment against me and try to collect against me. But again, that'll take some time and processes.

18           And I'm willing—so I decided that the best thing to do is just not allow them to distract  
19 me, not go into the courts, not spend all that money, just allow them to do what they're doing—not  
20 really allow, because it's my way of really defending myself. Just let them give a default judgment  
21 against me and then I'll deal with it after that. Meanwhile, I'm running a very solid campaign,  
22 meeting with thousands of people all over Idaho and doing these really important things, not being  
23 pulled into the court.

1           So yesterday that wasn't good enough for St. Luke's and the CEO of St. Luke's. That wasn't  
2 good enough. So they told their attorneys to file for contempt charges against me. Well, this is  
3 where it starts to get criminal, where it's contempt. So they can order my arrest, throw me in prison  
4 until I give them what they want, till I participate. So they're mad that because I won't go play in  
5 the sandbox with them. They're all mad and then they want the teacher to force me to go play in  
6 the sandbox. And I refuse. I refuse to go play in the sandbox with them. So they're trying to use  
7 the court.

8           When the easy path or the correct legal path is to just get a default judgment against me  
9 and then go in to try to go into collections. But they don't want to do that. They want to force me  
10 to participate, force me. And this is a civil case. This is not a criminal case. This is like your  
11 neighbor suing you. And then your neighbor saying, "Well, we don't like how he's proceeding or  
12 he's not proceeding the way we want. So we want you, Judge, to go throw this guy in jail until we  
13 get what we want."

14           Well, interestingly enough, yesterday and today, I got some mail from the judge, from  
15 Judge Lynn G. Norton. And I guess she's the judge in the case. I've never met her. I saw a picture  
16 of her just because someone sent it to me. And she sent me several documents. So, Judge, I did  
17 get these documents. I did get them. And one's for Ammon Bundy for Governor, one's for People's  
18 Rights Network, and the other one's directly to me, Ammon Bundy.

19           And they came in three different things. And it is a motion or a court document titled,  
20 "Order for entry of default judgment against Ammon Bundy, Ammon Bundy for Governor and  
21 People's Rights Network." So the process of default judgment is happening. But yet on top of it,  
22 now they're trying to find me in contempt because I guess I won't participate—play with them in

1 the court. Well so, I mean that's why. That's ultimately the answer. And I feel good about getting  
2 that off my chest. And a lot of people wanted to know why I haven't been participating.

3 And if you look in the media, the lying fake media, they're making this look like it's a civil  
4 case—or excuse me, a criminal case, and that I am failing to appear. There is no such thing as  
5 failure to appear in a civil case. But they want you to believe that I'm not participating because of  
6 whatever reason they think, and that this is a civil case. And that somehow—talk about  
7 defamation, right? These people are just wicked people. They really are people that have an  
8 agenda. And they want to push their agenda through media rather than just reporting the truth.  
9 And true reporting is pretty much out the door.

10 So I'm asking you to take this video to share it. Share it with all your friends. Who's going  
11 to be offended if you share this video? No one should be offended, even if they don't like me.  
12 Share it with all your friends. This is why. This is the truth. And it has nothing to do with—I am  
13 more than capable of going and fighting and proving my points and doing all of that in court.  
14 Diego is, too. And Diego, I think, is going to fight. I don't know what he's planning on exactly,  
15 but I think he is going to fight. I think he's going to fight them and show them that everything he  
16 said was accurate and that they have to try to defend themselves against what he said because  
17 they're the ones that sued us.

18 And so anyway, I just didn't feel like I could—I didn't feel like I could leave the campaign  
19 trail and go and spend all this time and effort and money in the courts. And so that's where I'm at.  
20 And I hope that the judge makes the right decision, that I haven't participated, so she's going to  
21 have to enter a default judgment against me. I hope that she's just and reasonable in that and that  
22 the case is closed. Closed. And she doesn't try to use her powers to find me in contempt, or any  
23 of that garbage because she shouldn't. This is a civil case. And what is the result of me not




1 participating? It's called default judgment. And she should go through that process and this case  
2 should be over. And they can then try to collect and I can continue in my campaign and there  
3 should be no arresting or warrants for my arrest or there shouldn't be any contempt and throwing  
4 me in jail. There shouldn't be any of that. This is a civil case. And I have chosen not to participate  
5 so they can get a default judgment, if they want, and move on.

6           And so that's where it needs to be. And I feel good. I feel like I got this off my chest. I  
7 thank you for listening and watching and ask you again to share this video. Get it out there. I  
8 think it'll go far and wide if we can get it to our friends and outside the algorithm of Facebook. So  
9 thank you for your time. And I plan on doing this again with some other topics when it comes to  
10 my campaign. So thank you very much.

2 MR. AMMON BUNDY: Hello there. Thank you for watching. I did not want to really  
3 do this video but I feel like it's necessary, uh, because I need you to understand the situation that  
4 Diego and I are in when it comes to the St. Luke's case here.

5 Um, it's becoming -- it's escalating. Um, I've tried everything I could to, uh, make peace  
6 with St. Luke's executives and the Holland and Hart, uh, attorneys. But they've rejected every  
7 offer, you know, of peace, every token of peace that I've, uh, offered to them and they've actually  
8 come after -- after Diego and I even harder. Uh, so I just feel like I've been compelled to do this  
9 video to give you the information about what they're trying to do with this.

10 The latest is they're -- they're trying to, uh, get, uh, an arrest warrant for my arrest to hold  
11 me in jail and I'll give you those details. Um, so that's the reason for this video. And you're gonna  
12 want to watch clear to the end because I have some very, very important information that I need  
13 to show you of what's happening in Idaho.

14 Um, so -- well, first of all, we'll take a look at this, uh, these documents. I mean this is  
15 only two weeks' worth of court documents that's been sent from Holland and Hart, St. Luke's  
16 attorneys, to my house. And it comes from, you know, by the form of UPS, personal servers, the  
17 United States Postal Service, FedEx. The sheriff will drop some things off. Um, it's just crazy.

18 And -- and, uh -- and amongst all this, they are claiming that we are the ones that are  
19 continually harassing them. And it couldn't be -- they're claiming this in the court documents and  
20 so forth. It couldn't be further from the truth. It's just opposite. We just want to be left alone.

21 In fact, now St. Luke's executives and Holland and Hart, um, attorneys just filed yesterday  
22 with the courts a motion asking the courts to have me arrested and hold me in jail. And in the  
23 motion, which I have in my hand right now, it says that "We seek four things: (1) a warrant of



1 attachment for Bundy's arrest; (2) a conditional sanction placed on Bundy and, uh, PRN until they  
2 ever move the specific web pages." We'll talk about that here in a little bit. "(3) the criminal  
3 sanction of a fine in the amount set by The Court," so they want to fine me. And (4) their  
4 reasonable fees and costs in bringing this motion, so they want me to pay for their attorney fees.

5 Now just to go back to these web pages that they're talking about. Evidently there was a,  
6 uh, an order from the court that was issued to remove certain things on, uh, People's Rights  
7 webpage. Well, I didn't know anything about it so I had to go into and find out.

8 And come to find out after some research that an individual in Utah, in Area 3A and 3B,  
9 wrote an article - now this is in Utah; not in Idaho, Idaho - wrote an article titled "Baby Wrongfully  
10 torn from Arms of Mother" in Meridian -- in Meridian, Idaho. Sounds like a pretty honest title.

11 Well, in that article it states that, uh, uh, Chris Roth, president of CEO -- and CEO of St.  
12 Luke's was -- how did they state it? Uh, uh, a -- is criminal -- "is a criminal accessory to child  
13 abduction." And the court ordered that statement to be removed.

14 Uh, well, anyway, once I found it and I got the court order and I got some legal advice, we  
15 ended up moving -- changing it to "censored pending litigation." So I took off the, uh, "Chris  
16 Roth is a criminal accessory to child abduction" and added "censored pending litigation," right?

17 So we complied. Didn't want to comply because I believe it's free speech and I believe that  
18 he is -- um, you know, was an accessory to child abduction but, uh, the court ordered it and we --  
19 we changed it, uh, during the litigation.

20 Well, anyhow this is where we get to because now Holland and Hart/St. Luke's is actually  
21 lying to the court because they say they did not remove the offending material from the website.  
22 That's a lie. They go on to, uh, deceive The Court, and this is how they are deceiving The Court,  
23 by saying "As of the date of this filing the web pages have not been removed."

1 But if you remember, The Court didn't order the web pages to be removed; only the  
2 material, specific material, to be removed. So they're saying that I should be arrested now because  
3 I didn't remove the web pages.

4 And I just want to remind you: I didn't write this article. I didn't even know this article was  
5 written. It wasn't even written in Idaho. I'm a state assistant in Idaho. This was in Utah. People's  
6 Rights is a network that's completely, uh, decentralized. We don't control Utah; Utah doesn't  
7 control us; none of the other states.

8 And so for them to say this and accuse me of this, um, and then try to deceive the courts in  
9 this way to me is -- is unscrupulous. It's like somebody doing a YouTube video in Utah and  
10 someone doesn't like it so they sue another person in Idaho. How much does that make sense? So  
11 that's reason number one that they're asking The Court to arrest me or to issue a warrant for arrest.

12 Reason number two is last week I wrote an article titled "There's no Silver Bullet to  
13 Securing Liberty." And they say even though I -- I don't mention their name; I don't mention the  
14 situation. When I wrote it I had no -- it wasn't written in any way for the St. Luke's situation. It  
15 was a general statement saying what we must do to secure liberty. And in it I -- they -- they  
16 reference in their motion that this is the reason why they think I ought to be arrested because I  
17 threatened and intimidated them.

18 Now listen to this. They say that I wrote "Stop thinking that the courts or elected  
19 representatives are going to save us. Stop worshipping the police or anyone else that secures more  
20 power in to the institutions that are threatening freedom. Stop wasting your time thinking that  
21 Congress or the president is where the solution resides. Stop being afraid. Stop thinking that  
22 remaining free is easy. It's not. The people must balance the power that is forming against them.  
23 We must peacefully unite, plan and prepare, so we are able to defend ourselves as necessary. The

1 right to defend yourself is a right that is given to you from God and a right that is protected in our  
2 founding documents, the same document that means nothing unless they can be enforced by the  
3 people."

4 Now they emphasized in bold "enforced by the people" so I guess that's a -- what they  
5 mean by I intimidated or threatened them. I also wrote "It is going to take unity, suffering, and  
6 willingness to use violence in defense like it always has." And they're saying that somehow even  
7 though their names -- nothing, no name, no reference; nothing about the case, something totally  
8 separate; they're saying that because I wrote these things that I threatened and intimidated them.

9 In fact, they go on to say "They -- Bundy's recent threatening rhetoric has garnered  
10 significant media attention indicating the wide distribution of Bundy's harassment and  
11 intimidation." That's what they're saying.

12 So because of an article that someone wrote in Utah that was actually changed according  
13 to what the court order wanted, and because of an article that I wrote, uh, that had nothing to do  
14 with St. Luke's, they're saying that I violated the protective order that The Court has and that I  
15 should be arrested. That's what they're saying.

16 Now, and in this motion they call for The Court to issue a warrant four times; a warrant for  
17 my arrest four times. But on the last page it emphasizes something that seemed to be a pattern  
18 with Holland and Hart attorneys and St. Luke's executives.

19 And it says that they want me to pay all the attorney fees for this processes. They want  
20 me. Now speaking of that, Holland and Hart also filed a court document just recently asking The  
21 Court to award at least \$250,000 in punitive damages to each St. Luke's parties from each  
22 defendant in this case.

1           So let's do the math. If The Court gives Holland and Hart what they want, that means that  
2 St. Luke's Health System would receive \$1.5 million from Diego and I. On top of that, St. Luke's  
3 Regional Medical Center would receive \$1.5 million for Diego and I. On top of that, Chris Roth,  
4 the CEO of St. Luke's, would personally receive \$1.5 million from Diego and I. On top of that,  
5 Natasha Erickson, the doctor who misdiagnosed Baby Cyrus and called CPS, would receive \$1.5  
6 million from Diego and I.

7           And on top of that, a nurse by the name -- that works for St. Luke's by the name of Tracy  
8 Jungman would also receive another \$1.5 million from Diego and I. So that's a total of \$7.5  
9 million, uh, that Diego and I will have to pay these people plus all of Holland and Hart's attorney  
10 fees which is now reaching right around a quarter of a million dollars.

11           So what did these people do to earn this money, to deserve this money? Well, they  
12 participated in taking Baby Cyrus from his loving and caring parents. And what did Diego and I  
13 do to deserve everything we own and more stripped from us? Well, we said bad things about them  
14 for taking Baby Cyrus away. Bad things that are true that they did not want other people to hear.  
15 Things that were exposing them.

16           And what type of things did we say that were bad about them? Well, the same type of  
17 things that other people are saying about them. In fact, on February 7th in Idaho Tribune there's  
18 an article titled "Representative Bruce Gag -- Skaug introduced bill blocking child genital  
19 mutilation and puberty blockers in Idaho." The article is very interesting. It says "Yesterday,  
20 February 7th, is a day that will live in infamy -- infamy for groomers, child predators, Democrats,  
21 perverts, Satanists, sodomites, Antifa, pedophilias, and the senior executives of St. Luke's  
22 Hospital."

1           Interesting, right? The article goes on. It says "Representative Bruce Skaug introduced a  
2 bill that will make it a felony in Idaho to provide any kind of so-called gender affirming care that  
3 mutilates the reproductive organs of a minor." It talks about the bill.

4           There's a statement from the Idaho Republican party, Dorothy Moon, the chairwoman, and  
5 she says "In support of the bill, the fight to protect Idaho's children from pseudoscience and  
6 biomedical industrial complex is here." So the fight is here.

7           Now the article goes on and says "The medical industry and the Democrat party have been  
8 attempting to keep a lid on all of this because sexually assignment surgeries are an absolute gold  
9 mine for the health care field. These surgeries cost hundreds of thousands of dollars and are usually  
10 accompanied by years of care, dozens of different prescriptions, frequent complications, and  
11 ongoing care." So they make a ton and ton of money on these sex reassignment surgeries.

12           But why did this article list the senior executives of St. Luke's Hospital with the likes of  
13 groomers, child predators, Democrats, perverts, Satanists, and sodomites including Antifa and  
14 pedophiles? Why would they do that?

15           Well, here's another article that explains. It says -- this is from the Washington Stand. And  
16 it's titled "Thirteen U.S. hospitals perform gender transition surgeries on minors." The list -- it  
17 gives a list and it says, number one UCLA Pediatric Practices, Los Angeles, California. Two,  
18 Stanford Children's Medical Health, Palo Alto, California. Three, Connecticut Children's Hospital,  
19 Hartford, Connecticut. Four, St. Luke's Children's Hospital, Boise, Idaho.

20           It says "The Essence Clinic at St. Luke's Children's Hospital, Boise, Idaho, offers hormonal  
21 therapy including puberty blockers and surgical consultations and referrals to children,  
22 adolescents, and young adults. Two of its five providers specialize in surgery."

1 Now, I wanted to know this was true. I wanted to fact check it so I went to the St. Luke's  
2 website. Here you go. You'll see here it says "St. Luke's Children's Essence Clinic." That is found  
3 in the St. Luke's Children's Hospital. You remember downtown with the bear on top of it? There  
4 it is. There's a picture.

5 And it says "The team of specialists at St. Luke's Essence Clinic is dedicated to improving  
6 health and experiences for children, adolescents, and young adults with differences in sexual  
7 development and/or gender identity." Down here on 'Areas of Focus' it says "Our team provides  
8 hormonal therapies, mental health evaluations, and surgical consultations including plastic  
9 surgery."

10 So when I go to the transgender plastic surgery page, uh, on -- at St. Luke's website it says  
11 "St. Luke's plastic surgery team cares for the unique surgical needs of all transgender patients.  
12 They provide surgeries for female-to-male and male-to-female transitions including vasectomy  
13 with nipple grafts." That would be removing the breasts from a young girl. "Breast  
14 augmentations," that would be adding breast implants. Uh, facial feminization, body contouring,  
15 fat grafting, and orchiectomy. If you don't know what that is, that is removing the genitals from  
16 a young boy to try to make him like he's a girl. That's what that means.

17 It goes on. It says "Hormone treatments." And then down here, this would almost be  
18 comical if it wasn't so serious and gross of a matter. It says "The transgender woman has special  
19 health needs and may visit a gynecologist for care after gender affirmation surgery. On the other  
20 hand, a transgender man's needs must be addressed by a gynecologist."

21 So I mean if you're a woman, you go to a gynecologist no matter whether you've been  
22 turned to a -- try to turn into a man or not. And they're recognizing you; you still gotta go to a

1 gynecologist. Because why? Because they're the ones that understand the reproduction system of  
2 the woman.

3 And so even if you get a surgery at St. Luke's to try to make you like you're a man, you  
4 still gotta go visit a gynecologist. This is the -- the stuff that's going on. And St. Luke the  
5 evangelist would be turning in his grave right now. I'm sure he's turning over in his grave right  
6 now because the St. Luke's Hospital is just using his name and -- you know, and doing terrible  
7 things.

8 Here are the providers that provide the -- you know, these services. There's a plastic  
9 surgeon and, you know, who else. Here they are. Now I have to warn you, uh, I think this is  
10 important to show you though, but this would be something that, you know, you don't want your  
11 children to see.

12 These are some pictures of actual surgeries that are done to a minor, uh, in a sex change.  
13 And you can just imagine the trauma of the -- the body and just everything else going through this.

14 Now as a good friend of mine pointed out, this is being done to help these children where  
15 their reproduction systems are health. Everything, you know, is healthy. The -- their organs are  
16 healthy, but because they have been manipulated into getting some type of gender affirmation sex  
17 change, uh, they go through these type of trauma and medical procedures. It's just -- it's just  
18 wicked, my friends. It's just flat out wicked and it's being done right here in Idaho by St. Luke'.

19 And the same very people that are coming after Diego and I so ruthlessly, because we stood  
20 up for that little baby and their family and got that baby back to his parents, they're coming after  
21 us and wanting to completely destroy our lives.

22 Now, these are the very same people -- just to remind you, these are the very same people  
23 that sponsored the Boise Pride Festival which featured drag kids as young as eleven getting on

1 stage dressing up like drag queens and performing sexual acts in other people -- in front of  
2 everybody else. That's who these people are.

3 If you remember, here's the -- here's an actual, uh, uh -- some of the sponsors. This is just  
4 one page of the sponsors of Boise Pride Festival that were, uh, scheduled as -- had scheduled a  
5 drag kids show. And you see right there Holland and Hart, St. Luke's, uh, Department of Health  
6 and Welfare. CPS was one of them, you know. The Iacki [phonetic] Boys and, um, ultimately  
7 what this is -- what this case has become against Diego and I is just political retaliation for  
8 challenging the Idaho establishment's power.

9 St. Luke's Hospital is closely connected with the Department of Health and Welfare, CPS,  
10 the Governor's office, Holland and Hart, and Iacki. And we've challenged them many, many times  
11 especially during Covid.

12 Now just to make this connection, here's a list of just one, uh, portion of the Covid relief  
13 funds that went to St. Luke's Hospital. It's over \$121 million coming directly from the Governor's  
14 office to St. Luke's Hospitals and I just wonder how much of this money is going to mutilate  
15 children in Idaho.

16 Now, if you -- you know most of their annual funds come from donations that the good  
17 people of Idaho give to St. Luke's or tax payer dollars. And what are they using it for? They're  
18 using it for, you know, things like child, uh, sex changes and to pay high-dollar attorneys to come  
19 after their political enemies.

20 Here's a, uh -- on the Governor's website, uh, it shows here that right part of, uh, Governor  
21 -- Governor's working group, corona virus working group, is, uh, the CEO of St. Luke's was on it.  
22 And then here it shows how much he made in 2020 - \$8.5 million. And look at the treasurer for  
23 St. Luke's in 2020 made \$1.2 million. The treasurer.



1           These are coming from donations and tax payers. This was the -- prior to the Covid money  
2 so this is -- this is just donations and -- and tax payer money. And I just want to, you know, express  
3 to you what's really happening and who is really doing this to Diego and I and our families, and  
4 that we've been put under, uh, peril.

5           If the judge awards what they want, there will be an arrest -- a warrant out for my arrest.  
6 They'll arrest me and put me in jail. And, uh, you know, what do I do about that? They also, if  
7 the judge awards what they want, they will be awarded \$7.5 million of money that Diego and I  
8 don't have.

9           We're just family men. We don't have that money. So they'll take everything from us.  
10 They'll take our homes, our bank accounts, our vehicles; everything. Our businesses; they'll take  
11 everything from us. And there's just really no way to stop them. They're just -- they're -- St. Luke's  
12 is paying them hundreds of thousands of dollars just to bury us and there's just no way to respond.  
13 There has been no way to respond and they know that.

14           And so this is why I -- you know, I need you to be aware of what's going on and, uh, who  
15 is doing it and -- and why I felt like I had to do this video. Thank you.
