The above-captioned Plaintiffs (collectively, the "Judgment Creditors"), by and through their attorneys, Holland & Hart LLP, respectfully represent as follows for this, their Application for Writs of Execution as to Freedom Man Press PAC.

- 1. This Application is supported by the Declaration of Robert A. Faucher filed herewith.
- 2. On August 29, 2023, this Court entered a Default Judgment in favor of the Judgment Creditors and against Defendants Ammon Bundy, Ammon Bundy for Governor, Diego Rodriguez, Freedom Man Press LLC, Freedom Man PAC, and People's Rights Network (collectively, the "Judgment Debtors").
- 3. Among other things, the Default Judgment contained a money judgment in favor of the Judgment Creditors and against the Judgment Debtors jointly and severally in the amount of \$51,875,000, broken down as follows:<sup>1</sup>

- 4. All Judgment Debtors are jointly and severally liable for the Default Judgment. The Judgment Creditors "are entitled to have all damages owed to them to be collected jointly and severally from all Defendants." August 29, 2023, Order on Verdict and Default Judgment.
- 5. The Judgment Debtors have paid nothing toward the Default Judgment as of the date hereof.
- 6. No stay of execution exists. The Judgment Creditors intend to collect the Default Judgment in their favor against Ammon Bundy to the extent possible.
- 7. The Judgment Creditors hereby apply for the issuance of writs of execution under Rule 69 of the Idaho Rules of Civil Procedure, Idaho Code §§ 11-101 to 11-107, Idaho Code § 8-507, and other applicable law against Freedom Man Press PAC. Two proposed writs of execution against Freedom Man Press PAC are submitted herewith. One writ is directed to the Sheriff of Ada County and one writ is directed to the Sheriff of Gem County—each to collect the judgment in the amount identified in ¶ 3 above. Judgment Creditors believe that the Judgment Debtors may have assets in both Ada County and Gem County.

WHEREFORE, Judgment Creditors apply for the issuance of two writs of execution in the form submitted herewith.
