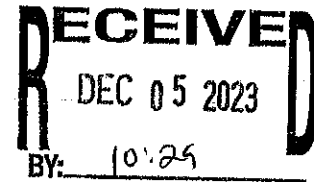

FURTHER, you are required to make return of this writ within sixty (60) days after receipt of this writ.

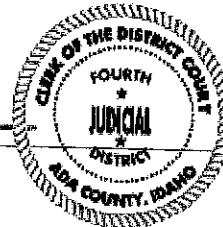
