ORDER

I, Robert A. Faucher, declare and state as follows:

### **Background**

- 1. I am one of the attorneys of record for Plaintiffs in this matter. I am familiar with the facts and proceedings in this matter and have personal knowledge of the matters stated in this Declaration.
- 2. I am a partner in the Boise office of the law firm of Holland & Hart LLP and am licensed to practice law in the State of Idaho. Along with my colleagues identified above, I am counsel for Plaintiffs-Judgment Creditors St. Luke's Health System, Ltd., St. Luke's Regional Medical Center, Ltd., Chris Roth, Natasha D. Erickson, M.D., and Tracy W. Jungman, NP (collectively, "Judgment Creditors").
- 3. I make this Declaration on behalf of Judgment Creditors in support of (1) their Application for Entry of Charging Order (Power Marketing Agency, LLC) and (2) their Application for Entry of Charging Order (Power Marketing Consultants, LLC). Both of these applications (the "Applications") pertain to equity interests of defendant-judgment debtor Diego Rodriguez ("Rodriguez") in Idaho limited liability companies.
- 4. On August 29, 2023, this Court entered a Default Judgment ("Judgment") in favor of the St. Luke's Parties and against Rodriguez and the five other defendants (collectively, "Judgment Debtors").
- 5. As of the date of this Declaration, the Judgment Debtors have paid nothing toward the Judgment. Nor have the St. Luke's Parties executed on any property to recover the Judgment. Nor have the Judgment Creditors recovered any money by means of a

garnishment.<sup>1</sup>

### The equity interests can be charged for Rodriguez's Judgment liability

- 6. Although Rodriguez has appealed the Judgment, the automatic stay of Idaho Appellate Rule 13 has long since expired. Nothing stays the relief Judgment Creditors seek in the Applications.
- 7. Evidence suggests that Rodriguez owns equity interests in two Idaho limited liability companies, Power Marketing Agency, LLC and Power Marketing Consultants LLC.
- 8. The Power Marketing Agency website indicates that it is owned by Rodriguez. It states that Rodriguez is "the founder and President of the Power Marketing Agency . . . ."

<sup>&</sup>lt;sup>1</sup> Rodriguez has taken steps to evade the Judgment Creditors, including using a virtual address and refusing to comply with discovery obligations. Collection activity is ongoing, although no monetary amount has yet been credited against the Judgment liability. Specifically, Judgment Creditors have garnished certain bank accounts, but the sheriffs presently hold the funds. Second, the Gem County Sheriff has levied upon a motor vehicle owned by Rodriguez, pending sheriff's sale. Third, one of the Judgment Creditors owns a Gem County residence previously owned by Judgment Debtor Ammon Bundy. However, the Judgment Creditor acquired title to that house by means of a negotiated settlement in the fraudulent conveyance lawsuit filed in Gem County—not by direct conveyance through collection legal process. The Judgment Creditor still owns the house; i.e., the house has not yet been converted into cash. Under these circumstances, it is unclear how the value of the house should be credited against the Judgment at this time. Regardless, however, the house is reportedly worth no more than \$1.5 million, so even if the value of the house were to be credited against the Judgment liability at some point, the outstanding unpaid Judgment would remain in excess of \$50 million. The Default Judgment's current balance is approximately \$51,875,000, exclusive of post-judgment interest. This amount does not give the Judgment Debtors a credit for the value of the residence nor any of the other property identified in this footnote.

- 9. According to the Idaho Secretary of State Website, Power Marketing Agency, LLC was administratively dissolved effective March 1, 2024. It remains dissolved as of the date of this Declaration. However, the St. Luke's Parties believe that it may have assets and that it may currently be selling various services and products and, therefore, potentially making distributions. Indeed, the Power Marketing Agency website, <a href="https://powermarketing.agency/">https://powermarketing.agency/</a>, is still active and still lists products and services for sale. A true and correct screenshot of the "Products and Services" page of the Power Marketing Agency website is attached hereto as **Exhibit B**.
- 10. On March 21, 2023, the St. Luke's Parties served Rodriguez with Requests for Admission in this lawsuit. Requests for Admission Nos. 66-68 ask Rodriguez to admit that he owns and controls Power Marketing Agency, LLC. Request for Admission No. 77 asks Rodriguez to admit that he received revenue in the form of income, disbursements, or payments from Power Marketing Agency, LLC during 2022. Rodriguez refused to respond to these Requests for Admission. They are, therefore, deemed admitted pursuant to Idaho Rule of Civil Procedure 36. A true and correct copy of excerpts of the Requests for Admission that were served on March 21, 2023, are attached hereto as **Exhibit C**.
- 11. A true and correct copy of the last Annual Report filed with the Idaho Secretary of State for Power Marketing Agency, LLC, dated December 2, 2022, is attached hereto as **Exhibit D**. None of the capacities identified there for Miranda Chavoya evidence that she is a member (owner) of the limited liability company.
- 12. According to the Idaho Secretary of State website, Power Marketing Consultants LLC was administratively dissolved effective April 13, 2023. It remains dissolved as of the date of this Declaration. However, based in part on Rodriquez's continuing business activity under

this name, the St. Luke's Parties believe that it continues to take corporate actions, may have

assets and that it may currently be selling various services and products and, therefore,

potentially making distributions. At the time of its dissolution, Judgment Debtor was identified

as its registered agent and manager.

13. Attached hereto as **Exhibit E** is a true and complete copy of the most recent

annual report that Power Marketing Consultants LLC filed with the office of the Secretary of

State of the State of Idaho. No natural person other than Rodriguez is identified in any filing of

Power Marketing Consultants LLC in the Secretary of State's office. Although Power Marketing

Consultants LLC was administratively dissolved by the Secretary of State of the State of Idaho

on or about April 13, 2023, Judgment Creditors' attorneys believe that it may nonetheless be

selling various services and products, and, therefore, potentially making distributions to

Rodriguez.






