**ORDER CHARGING LIMITED  
LIABILITY COMPANY INTERESTS OF  
JUDGMENT DEBTOR DIEGO  
RODRIGUEZ**

THIS MATTER having come before the Court on Plaintiffs St. Luke’s Health System, Ltd., St. Luke’s Regional Medical Center, Ltd., Chris Roth, Natasha D. Erickson, M.D., and Tracy W. Jungman, NP’s (collectively, “Judgment Creditors”) Applications for Entry of Charging Orders (“Applications”) and the Court being fully advised in the premises,

IT IS HEREBY ORDERED, AND THIS DOES ORDER:

1. That the individual interests of Defendant Diego Rodriguez (“Rodriguez”) in Power Marketing Agency, LLC and Power Marketing Consultants LLC (collectively, the “Limited Liability Companies”) is charged with the payment of the unsatisfied judgment (“Judgment”) entered in favor of Judgment Creditors and against, among others, Rodriguez as follows:

2. Based on the Applications, the amount that remains due and owing on the Judgment is \$51,875,000, exclusive of post-judgment interest.

3. From the date of service of this Order upon the Limited Liability Companies, they are hereby directed to pay to Judgment Creditors all present and future shares of income, profit, distribution, payments, revenues, and any other money or property which, but for this Order, would be paid to Rodriguez by virtue of or in respect of Rodriguez's interests in the Limited Liability Companies, until such time as the Judgment shall be paid in full. All such payments to Judgment Creditors shall be made payable to St. Luke's Health System, Ltd. and delivered to the Judgment Creditors in care of Erik F. Stidham, Holland & Hart, LLP, 800 W. Main Street, Suite 1750, Boise, ID 83702, or such other address as may be specified by Judgment Creditors in written notice to the Limited Liability Companies.

4. Pursuant to Idaho Code Section 30-25-503(a), this Order shall constitute a lien on Rodriguez's transferrable interest in the Limited Liability Companies to secure the payment of the Judgment.

5. Rodriguez shall not sell, assign, transfer, encumber or hypothecate all or any portion of his interest, or any distribution thereof, in the Limited Liability Companies until such time as the Judgment is paid in full.

6. The Limited Liability Companies shall not consent to any sale, assignment, transfer, encumbrance or hypothecation by Rodriguez of all or any portion of Rodriguez's interest in the Limited Liability Companies until such time as the Judgment is paid in full.
