THIS MATTER having come before the Court on Plaintiff's *Motion for Order to Show Cause Against Garnishees* Abish-husbondi Inc. and Dono Custos, Inc. and the Court having held a hearing on June 17, 2024 wherein Garnishee Abish-husbondi Inc. and Dono Custos, Inc. failed to appear or otherwise answer the garnishment as required by Wyo. Stat. Ann. § 1-15-407, and the Court being fully apprised in the premises, FINDS:


Garnishees Abish-husbondi Inc. and Dono Custos, Inc. were properly served with a Post-Judgment Writ of Non-Continuing garnishment on March 19, 2024. Garnishees failed to answer or otherwise respond to the Writ as required by Wyo. Stat. Ann. § 1-15-407. A hearing was held on June 17, 2024, pursuant to Wyo. Stat. Ann. § 1-15-414 wherein garnishees failed to appear.

IT IS HEREBY ORDERED that default judgment pursuant to Wyo. Stat. Ann. § 1-15-414 is appropriate and;

IT IS FURTHER ORDERED that default judgment shall be granted against garnishees Abish-husband Inc. and Dono Custos, Inc. in the total amount of \$50,000,000.00 allocated to each Judgment Creditor as follows:
