A MOTION TO AUGMENT THE RECORD with copies of the requested documents attached to the Motion, MOTION TO DISMISS APPEAL, and MEMORANDUM IN SUPPORT OF MOTION TO DISMISS APPEAL were filed by counsel for Respondents on March 6, 2025. A RESPONSE TO MOTION TO DISMISS APPEAL was filed by Appellant on March 21, 2025; therefore,

IT IS ORDERED that Respondents' MOTION TO AUGMENT THE RECORD is CONDITIONALLY GRANTED, and the following documents shall be added to the augmentation record:

1. Order Quashing and Recalling Warrant Issued as to Diego Rodriguez, file-stamped June 1, 2023;

2. Motion for Contempt Against Diego Rodriguez, file-stamped May 8, 2024;

5. Notice of Hearing on Motion for Contempt Against Diego Rodriguez, file-stamped May 9, 2024; and
6. Order Denying Defendant Rodriguez' Notice Requesting Remote Video Access to Court Trial, file-stamped July 9, 2023.

IT IS FURTHER ORDERED that counsel for Respondents shall file a Reply Brief supporting Respondents' Motion to Dismiss on or before fourteen (14) days of the date of this Order.

IT IS FURTHER ORDERED that the due date for Appellant's Reply Brief shall be set, and Appellant's Reply Brief shall be filed with this Court on or before twenty-one (21) days of the date of this Order.

IT IS FURTHER ORDERED that Respondents shall pay the \$2,100.00 fee to augment the Clerk's Record (1,050 pages at \$2.00 per page) on or before fourteen (14) days of the date of this Order per I.A.R. 30(b). Failure to timely pay the fee shall result in the denial of the augmentation.
