The People of the State of Idaho to the Sheriff of Canyon County, Greetings:

On August 29, 2023, the Plaintiffs in the above-named matter received a judgment in the District Court of the Fourth Judicial District of the State of Idaho, in and for the County of Ada, CV01-22-06789, against Defendants Ammon Bundy, Ammon Bundy for Governor, Diego Rodriguez, Freedom Man Press LLC, Freedom Man PAC, and People's Rights Network (collectively, the "Judgment Debtors"), jointly and severally, for \$51,875,000.

NOW YOU, THE SHERIFF, are required to satisfy the judgment in the amount of **\$49,000,000** out of the personal property of **the Judgment Debtors, except Judgment Debtor Ammon Bundy**, or if sufficient personal property of the Judgment Debtors cannot be found, then out of the real property in your county belonging to those persons.
